# Replacement Capital Levy for Educational Technology, Health and Safety Improvements

The Board of Directors of Washougal School District No. 112-6 adopted Resolution No. 2022-23-08, concerning a proposition to finance educational technology, health and safety improvements. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, to acquire and install educational technology equipment and infrastructure and provide technology support, upgrade building access controls, make ADA accessibility improvements, replace/repair boilers and roofs, and modernize flooring:

#### **EXPLANATORY STATEMENT**

This proposition authorizes Washougal School District to replace an expiring capital levy. Taxes collected from this replacement levy will be used to make District-wide educational technology, health and safety improvements, including: (1) acquiring and installing educational technology equipment and infrastructure and providing related staff training and support; (2) upgrading, acquiring and installing building access controls and other safety and security systems; (3) making ADA accessibility improvements for main entrances; (4) replacing or repairing boilers and roofs; and (5) modernizing flooring. #### STATEMENT FOR

Not a New Tax

The Capital levy will not increase taxes. The bond payments on our schools start to drop off in 2025. As this happens, the Capital levy will increase by the same amount, keeping taxes flat while protecting important investments.

Spend a little now, or a lot later

Business owners know that a dollar invested in preventative maintenance saves four by avoiding future repairs. Washougal has great school buildings, some of them have lasted almost 90 years. Spending wisely now to keep them in great shape will prevent major issues down the road. We can only postpone these improvements so long before we will need to replace buildings instead of doing repairs, which will cost way more! Protect your investment in our schools by voting yes.

Technology to build job readiness skills
Students and teachers use technology every day in
the classroom. The capital levy keeps the technology
updated and working well. It also funds web filters and
safety tools to keep students focused on productive
uses of technology. School provided devices help
students build job readiness skills to enter the workforce,
military, college, or trade school ready to compete in an
increasingly digital workplace.

#### Security investments

The Capital levy invests in modern security systems to keep kids and teachers safe. Schools need to be able to respond quickly, and updated security doors will improve our schools' safety. While we never want awful things to happen in our community, we need to make sure our schools are prepared.

#### REBUTTAL OF STATEMENT AGAINST

The vast majority, almost 70% of voters, didn't vote in the February election. Running the election again provides an opportunity for the Washougal community to step up in support of kids and teachers. While the capital levy does increase over the three years, the entire increase is offset by decreases in the bond payments that happen starting in 2025, so tax rates will remain stable over the next three years. Vote Yes for schools!

Nothing has changed in the ask. This is a "replacement levy" in that it's a new 3 year replacing the old 3 year. This time they ask for \$9,050,000 vs the old levy of \$2,613,000. Simple math says that this "replacement levy" is an increase of \$6,437,000 = a 246% increase? Inflation is dramatically higher but not 246%! Have your earnings gone up 246%? They will want you to focus on the "rate per \$1000" instead of the actual amount of money, it's meaningless.

# Replacement Educational Programs and Operations Levy

The Board of Directors of Washougal School District No. 112-6 adopted Resolution No. 2022-23-05, concerning a proposition to finance educational programs and operation expenses. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, to maintain current educational program funding levels and support the District's educational programs, student services and operations expenses not funded by the State of Washington:

#### **EXPLANATORY STATEMENT**

This proposition authorizes Washougal School District to replace an existing educational programs and operations levy that will expire at the end of 2023. The proposed replacement levy will continue funding educational programs and operations that are not fully funded by the State, including supplies, textbooks, library, teacher and staff support, technology, athletics, transportation and facility maintenance and operations. Taxes collected by the proposed replacement levy will provide approximately 18% of the District's General Fund budget. Further information is available at www.washougal.k12.wa.us. Exemptions from taxes may be available, call your county assessor for more information.

#### STATEMENT FOR

As parents, business owners, and involved community members, we urge you to vote yes! Great communities have great schools, and great schools are the heart of strong communities. Our kids and grandkids need the programs and staff the levy supports to find success.

These are not new taxes!

Washougal voters have supported the EP&O levy for more than 40 years. We have talented teachers, successful schools, and our community's youth deserve our support. If levies fail again, 20% of the staff will get cut. Class sizes will go up, our kids will not have the support they need.

#### **REBUTTAL OF STATEMENT FOR**

Lets get the facts straight: This is a *tax increase of* \$7,500,000 (31.25%) which will increase mortgage payments and rent. This money goes mostly to teachers and not maintenance. Student population is down over 6%. 62.7% are failing math! 46.7% are failing English language. Only 61.2% of students regularly attend school! # Replacement School Support Levy for Educational Programs and Operations

The Board of Directors of Woodland School District No. 404 adopted Resolution No. 23-01 concerning the replacement of an expiring school support levy. This proposition provides funding for educational programs and operations not funded by the State. If approved, Proposition 1 will authorize the District to levy the following excess taxes, on all taxable property within the District, all as provided in Resolution No. 23-01:

#### **EXPLANATORY STATEMENT**

Passage of Proposition 1 authorizes the District to renew an expiring levy for educational programs and operations by levying \$5,900,000 for collection in 2024, \$6,250,000 for collection in 2025, and \$6,625,000 for collection in 2026. In accordance with Resolution No. 23-01 approving this proposition, these taxes would be deposited into the District's General Fund to pay for educational programs and operations of the District not funded by the State. These include teachers and staff, school supplies, facility improvements and maintenance, learning technology, arts and athletics, and specialized educational programs.

Based on projected assessed valuation information, the District estimates tax rates of \$1.91 per \$1,000 of assessed value for collection in 2024, 2025 and 2026. These estimated rates are lower than the tax rates of the expiring levy.

Under State law, tax exemptions may be available to homeowners age 61 or older, and disabled persons who meet certain income requirements. For information regarding exemptions, call the Cowlitz County Assessor at (360) 577-3010 or the Clark County Assessor at (564) 397-2391.

#### STATEMENT FOR

Vote Yes for Woodland's children!

Renewing Woodland Public Schools' Educational Programs and Operations Levy is critical for the quality of education our children receive in Woodland's schools.

The levy is not a new tax.

This levy renews the existing levy expiring in 2023. Without the levy, the district must cut \$3,000,000 from next year's budget followed by additional cuts the following year. The district must make drastic cuts to technology, security improvements, facilities maintenance, athletics, extracurricular clubs, specialized courses, and more.

Such cuts will increase class sizes, decrease learning opportunities, and leave our kids unprepared for the next steps after graduation. Not replacing the levy will profoundly negatively affect the educational experience our children receive.

Levy taxes will be lower in 2024.

To address these difficult economic times, the Board of Directors lowered the taxes the levy will collect in 2024, reducing the taxpayer's burden by nearly 9%. While the amount collected will increase in 2025 and 2026 to address growth in the Woodland community, the tax rate is expected to remain at \$1.91 per thousand of assessed value for all three years.

Vote yes for our kids' futures

Woodland Public Schools' mission is to prepare students for careers, life, and college. A yes vote shows you support this mission. Without the levy, our kids will not have the educational opportunities they deserve. Thank you for your approving Woodland Schools' current EP&O levy and for your yes vote for renewal. #### **REBUTTAL OF STATEMENT AGAINST**

#### STATEMENT AGAINST

Woodland School District is running a special election, a second request for a three year "excess tax" levy to collect a total of \$18,775,000 from property owners in the Woodland School District.. The voters already said *no* by a wide margin, and that was no surprise. This levy amount is 8.8% higher than the previous levy. This election will cost the taxpayers approximately \$60,000, in addition to the \$30,000 expense for the February failed levy.

We are experiencing a 40-year inflation high which is felt at the grocery store, gas pump, rent increases, property taxes and water and sewer rate hikes. Under the prevailing circumstances, many taxpayers of the district are feeling financial pressures like never before. It is not just a matter of the pocketbook. It is equally concerning that student standard outcomes are poor. Woodland ranks #231 in Washington state high schools. Only 50.85% of students meet the English Language Arts standard, 34.7% meet the Math standard, and 45.1% meet the Science standard. These competency numbers are disturbing.

The cost per student is \$16,547, which is 5.4% higher than the State average. We are investing more money than average in our students, but students are lower than the state averages in academics. Clearly, more money is not the answer. These facts are a compelling no vote on your ballot.

In closing, Woodland Public Schools removed the comment feature from their social media during the election, limiting the voice of the taxpayers. Your vote is your voice.

#### REBUTTAL OF STATEMENT FOR

It's not hard. Vote with a clear conscience. January 2012, the Washington State Supreme Court ordered the state to fully fund K-12 public schools as required by Article IX of the Washington State Constitution. (McCleary Decision) This levy asks for "excess taxes" beyond the state's full funding. The district needs to make responsible budget cuts without threatening to drastically eliminate programs that would negatively affect the educational experience of students. Vote responsibly. Vote no.
