#### BACKGROUND

In May of 2012, the Prosecutor's Office made a request for a classification review of several positions in our office. This request was intended to be proactive by making the most efficient use of positions and "right sizing" the classifications. One of the positions affected by the request was being vacated in October of 2012. The Prosecutor's Office had contemplated leaving the position vacant until an assessment of needs could be done to determine how the position would be used in the future. Because we did not identify how that position would be used in our classification request, it was assumed that the position would remain vacant and therefore could be deleted. As October approached, the Prosecutor's Office determined that the position needed to be filled, but at a lower classification, and subsequently revised the request for classification review to include the new classification for the vacating position. By this time, the position had already been removed from the Prosecutor's budget for 2013/2014 and had been advertised as such for the public hearing for the October supplemental.

#### **COMMUNITY OUTREACH**

#### **BUDGET AND POLICY IMPLICATIONS**

The final request for classification review resulted in a cost savings over the biennium of \$10,773. However, with the legal secretary position having been deleted from our budget, the salary and benefits for that position need to be added back in to the Prosecutor's budget (adding this position back into the budget still has a net result of \$10,773 in savings). The budget adjustment and the FTE adjustment will be presented at the next available supplemental budget process.
