- (7) A copy of your contractor security bond.

Once your application has been reviewed and you are deemed an 'approved' contractor for the County, you will receive notice via email. You will also receive an email from the County Auditor's Office, with a link to Workday (our payment software), requesting that you create an account and submit payment/invoicing information to the County in order to receive payment for work completed on County projects. We no longer request this information in hard-copy format; this is an automated, online process.
