UPDATES FROM THE EXECUTIVE TEAM

Facilities Move

Clark County officials intend to renovate the Clark County Jail. Renovation plans involve expanding jail and court services in the lower level, where the Sheriff's Office Administrative services are located. As a result of the renovation plans, all Sheriff's Office staff working at the downtown location will move across the street to the Public Service Complex. The moves include employees working in Sheriff's Administration, Records/Support, Public Disclosure, Civil/Extraditions, Sex Offender Unit, Campus/Courthouse, Training, and Human Resources. The downtown relocation will occur by year's end or early 2025. Sheriff's Office employees working in Patrol, Major Crimes, Tactical Detectives, Traffic, Special Investigations Unit, Children's Justice Center, and Logistics will not be affected.

The move to the Public Service Complex is temporary, allowing the County to find a more permanent location for the Sheriff's Office. Sheriff Horch aims to consolidate all CCSO services for increased efficiency and better service to citizens. La Center

Clark County and the City of La Center have agreed to a temporary contract for CCSO to provide police services to La Center. Cmdr. Phil Sample will continue to serve as the Interim Chief there, along with two assigned CCSO deputies. All parties, including CCSO, DSG, the County Manager, and the City of La Center, are working on a long-term contract that should be completed within a few months.

Legislative Update

This year's WA state legislative session ended in March. As there are every year, specific changes to state laws will affect law enforcement and public safety. A CCSO policy team reviews these changes to determine what, if any, policy changes or procedures need to be adapted or implemented. Town Hall

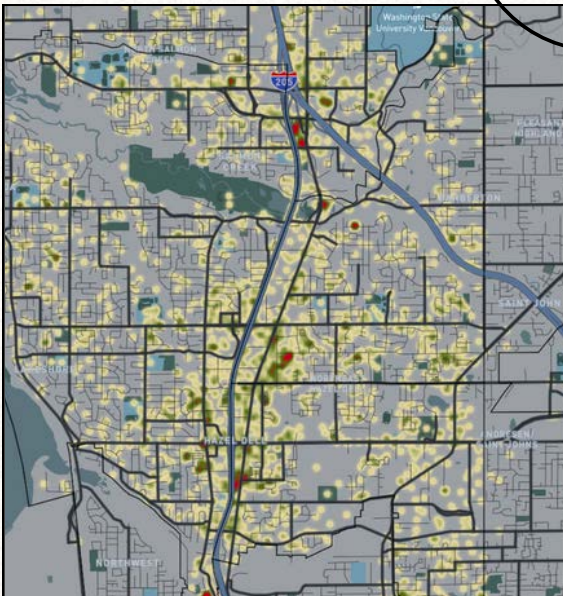

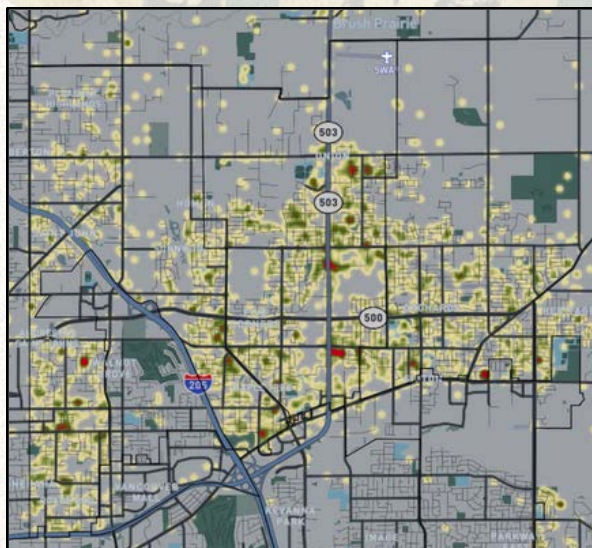

Case Spotlight

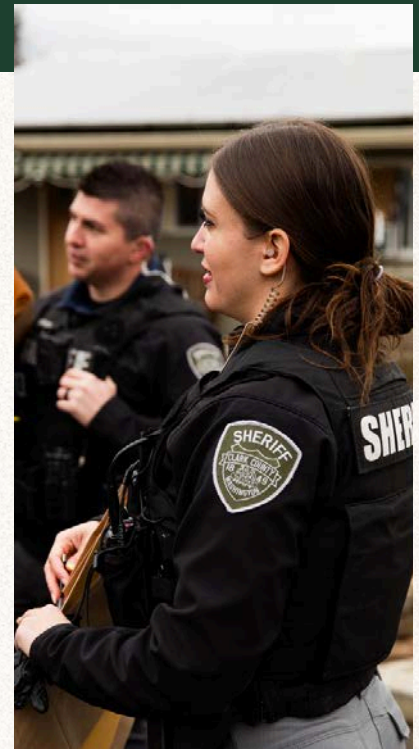
MCU ARREST

In February, MCU Detectives arrested Gilbert Stamps for Possession of Depictions of a Minor Engaged in Sexually Explicit Conduct. Investigators seized multiple electronic devices from Stamps's residence and, so far, have uncovered more than 12,000 media files containing depictions of minors.

Background on the investigation:

In January 2023, Detective Estefania Silveria, assigned to the Internet Crimes Against Children Task Force, began investigating a series of linked tips from the National Center for Missing and Exploited Children. Several Electronic Service Providers reported digital media files that were flagged as Child Sexual Abuse Imagery.

Through the course of an intensive, year-long investigation and numerous search warrants, Detective Silveria identified several dozen media files as containing suspected depictions of minors engaged in sexually explicit conduct. Detective Silveria identified the suspect as Gilbert Stamps (46) of Vancouver.



MCU Detectives served a search warrant at Stamps's residence and seized numerous electronic devices. Detectives arrested Stamps and booked him into the Clark County Jail. Detective Silveria began analyzing the electronic devices seized from Stamps's residence. At this time, more than 20,000 media files have been located, and evidence indicates at least 12,000 of those contain depictions of minors.

The Clark County Sheriff's Office continues to investigate the disappearance of Alana Carroll, who was reported missing in September of 2023. Before her disappearance, Alana had been staying at various residences in northern Clark County as she struggled with substance abuse issues. Information from the public has led the CCSO Major Crimes Unit to search several locations, but she has not been located. At the time of her disappearance, Alana was 32 years old. She is described as a fair-skinned female, 5'6" tall with a slim build, with brown hair and blue eyes.

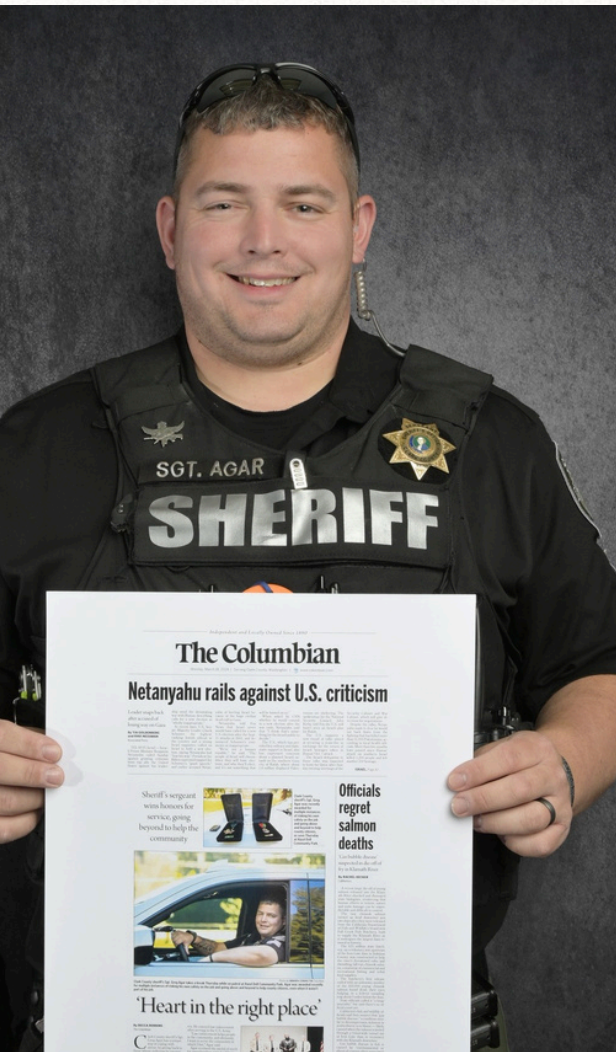


CRYSTAL COTTLE

On the evening of January 4, 2023, at approximately 9:24 p.m., Crystal Cottle, a 58-year-old mom and grandmother, became stranded in Ridgefield, WA, near Ilani Casino. She was experiencing hardships but was determined to return home to Springfield, OR. She subsequently headed to the southbound I-5 on-ramp at NW 319th St., where she was last seen hitchhiking. She has not been seen or heard from since.

Crystal is described as a white female with long wavy blonde hair and hazel eyes, 5'2" tall and roughly 130lbs. She was neatly dressed in a bright blue winter jacket over a tan/yellow sweater and tan turtleneck shirt. She was carrying a large black rolling duffle bag.

SGT. AGAR

CO-RESPONDER PROGRAM

Did you know that CCSO now has a specialized program to assist people in crisis? In December 2023, we partnered with Sea Mar Community Health Centers to launch the Co-Responder Program. It partners deputies with behavioral health professionals to respond to calls involving community members in crisis who have underlying behavioral health issues.

If they respond to the scene, Co-responders can assess, recommend resources, and coordinate care with other providers. Deputies can work alongside Co-responders and, if needed, will stay on the scene to ensure the safety of all involved. Depending on the situation, Co-responders may continue the intervention without the deputy, allowing the deputy to return to service.

We are grateful for the partnerships that keep this program running and look forward to continuing to make a positive impact in our community!



DATA

Data from the program's first five months indicate regular use by CCSO deputies, with an average of approximately 19 calls per month to Co-responders.

FUNDING

Carelon Behavioral Health is currently funding the pilot program. Carelon and funds from the Clark County Mental Health Sales Tax will collaboratively fund the program in the future. The Clark County Council recently allocated these specialized tax funds to the 2024 Annual Budget.

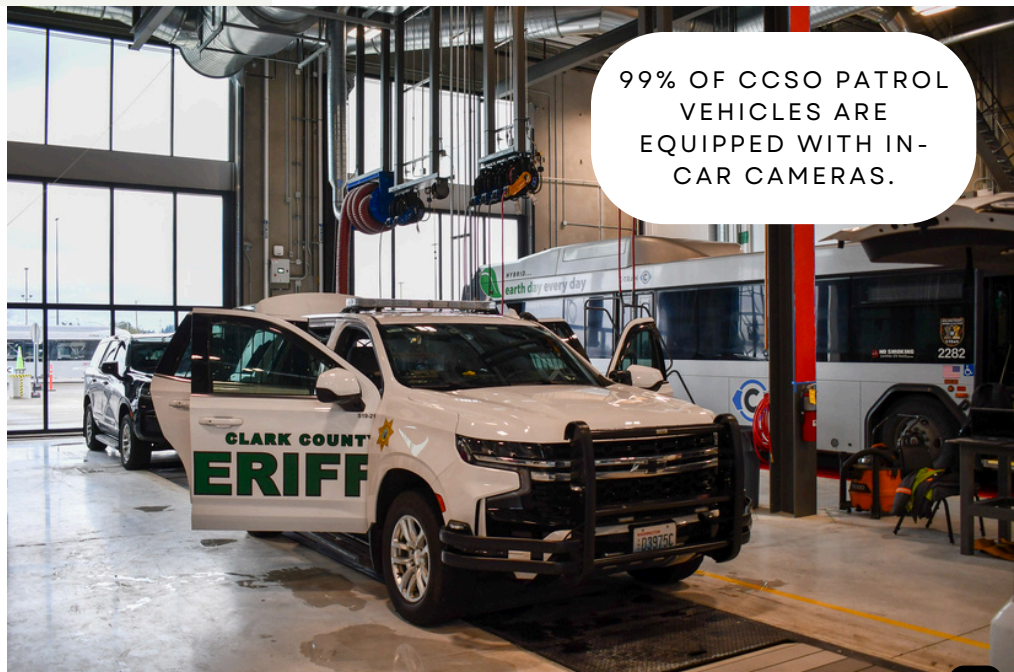

Ten members of our Sheriff Auxiliary recently received training and authorization as Junk Vehicle Inspectors. They are now equipped to assist property owners who would like junk vehicles removed from their property. Collaborating with the Traffic Unit, we devised a system for citizens to request this service via our CCSO website. Since March, the Auxiliary has conducted inspections and successfully processed ten junk vehicle affidavits, commonly known as hulk slips. This streamlined procedure allows deputies to focus on more urgent matters and eliminates the need for dispatch involvement.

As they got closer, they could see a man clinging to the side of his capsized aluminum boat and yelling for help. Dep. Childers was concerned other people may be in the water, which fortunately was not the case. The two gave the man a rope and helped him into the back of their boat. Luckily, he was wearing a life vest and was uninjured, but he was likely in shock as the river temperature was in the 40s. Dep. Childers and his friend called 911 and transported the man to the Marina, where fire and medical personnel were waiting. Great work to Dep. Childers and his friend who prevented what could have been a tragic outcome.

CAN YOU SHARE A LITTLE ABOUT YOUR JOURNEY BEFORE JOINING THE CLARK COUNTY SHERIFF'S OFFICE?

I am a 1st generation immigrant from South Korea. I grew up in Southern California and Attended UC Irvine School of Engineering after high school, but I realized it was not the right fit for me. I was trying to live a dream that my parents had for me, but I did not find fulfillment in living their dream. Through a referral from a friend, I was plugged into the Mortgage Real Finance industry. I worked my way up to working as a Conventional and Government Underwriter for approximately 20 years. Although I enjoyed this line of work and the pay was great, I felt something needed to be added. While in this line of work, I moved to Beaverton, Oregon, about 13 years ago to help a church minister to High School and College youth. I left all my family and friends behind in California for what I believe was a calling.

WHAT INSPIRED YOU TO PURSUE A CAREER WITH THE CLARK COUNTY SHERIFF'S OFFICE?

I've wanted to be in law enforcement since I was about six. I experienced what can be described as a traumatic event. My parents, younger brother, and I strolled around our neighborhood at dusk. We immigrated to America from a country where walking around with family in the evenings was familiar and safe. We later realized the neighborhood we moved into was not safe. During our stroll, a car pulled up beside us, and two male individuals got out of the vehicle and robbed us. One of the individuals grabbed my mother around her neck with his arm, and the other individual shouted commands to my father to give them some money. Fortunately, my father had some cash in his pocket and threw it onto the ground. I recall hearing a female voice in the vehicle shouting, "Let's go!" One guy picked up the cash, the other guy let go of my mother, and they both jumped into the vehicle. It sped away immediately. I don't remember much of what happened after. We lived in that neighborhood for about two years, and there was a Police Officer who would patrol the neighborhood occasionally. Each time the neighborhood kids saw the Officer patrolling, he would stop and hand us sports cards and stickers. I always felt safer when he was around. I wanted to be like him when I grew up.

AS YOU SETTLE INTO YOUR NEW ROLE, WHAT ARE YOU MOST EXCITED ABOUT LEARNING OR ACCOMPLISHING IN THE NEXT YEAR?

As I settle into the new role, I look forward to learning and growing as a Deputy who can positively impact the community and help make the community members feel safer in Clark County. I anticipate the challenges encountered in the learning/growing process as a Deputy and am eager to adapt and overcome these challenges. There is something to learn daily, and this profession is no exception. By the end of the year, I plan to complete probation and become a true asset to CCSO and my squad mates.

LAW ENFORCEMENT CAN BE CHALLENGING. HOW DO YOU PLAN TO BALANCE THE JOB'S DEMANDS WITH YOUR PERSONAL LIFE?

I am grateful for my wife. She supports my career change to law enforcement and is willing to adapt alongside me. With that said, I believe strongly in the saying "Family First." With every opportunity I get to spend with my family, I try to make the most of each second. The goal is to focus on work when at work and focus on family when I'm with them. But even with that goal in mind, my wife always wants to hear about my day at work, so I'll have to do some filtering and exercise discernment in what I share. Gotta keep the wife happy!

CAN YOU SHARE A FUN FACT ABOUT YOURSELF THAT YOUR COLLEAGUES MIGHT NOT KNOW?

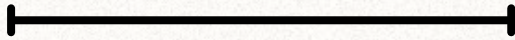
Cilantro tastes like soap to me.

CAN YOU SHARE A LITTLE ABOUT YOUR JOURNEY BEFORE JOINING THE CLARK COUNTY SHERIFF'S OFFICE?

Before coming to CCSO, I mainly worked as a freelance video production specialist, creating anything from small commercials to larger projects like documentaries or short films. In between gigs and post-Covid, I also had roles working in the medical field as an administrative assistant and as a technology coordinator for a local electrical contractor. Even at those positions, I kept up with smaller video projects that were either personal or paid.

WHAT INSPIRED YOU TO PURSUE A CAREER WITH THE CLARK COUNTY SHERIFF'S OFFICE?

I decided to join CCSO partly because I've wanted to pursue work in the government for stability, which was lacking for a time after the local film industry in Portland slowed down a few years ago. As I become more familiar with public disclosure rules, I look forward to being exposed to more interesting cases and working closely with the body camera footage.

One thing I have always done in previous jobs is ensure that whenever I'm not on the clock, I am fully disengaged from the job. I plan to use my off time to relax, pursue some of my hobbies, and spend time with friends and family. And if the job pressure starts to wear on me, I plan to make sure I have people to talk with instead of internalizing it.
