General Obligation Bonds - \$40,465,000

The Board of Directors of Ridgefield School District No. 122 approved Resolution No. 2019-2020-010 concerning this proposition for bonds. This proposition would authorize the District to construct and equip a new K-6 elementary school and accessible, inclusive playgrounds at South Ridge and Union Ridge Elementary Schools, by issuing \$40,465,000 of general obligation bonds maturing within 21 years; and to levy excess property taxes annually to repay the bonds, as described in Resolution No. 2019-2020-010.

Proposition Restoring Property Tax Levy For Fire Protection and Emergency Medical Services.

The Board of Clark County Fire Protection District No. 6 adopted Resolution No. 2020-03 concerning a proposition to maintain and adequately fund District operations.

This proposition authorizes the District to restore its regular property tax levy to \$1.50 per \$1,000 of assessed value to be assessed in 2020 and collected in 2021. The funds will maintain and improve fire protection and emergency medical services, replace apparatus, equipment and facilities and provide for firefighter safety. The maximum allowable levy in 2020 shall serve as the base for subsequent levy limitations as provided by chapter 84.55 RCW.
