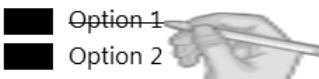

The Board of Directors of Battle Ground School District No. 119 adopted Resolution No. O-20, concerning replacement of an expiring levy for educational programs and operations. This proposition provides funding for educational programs and operations expenses not funded by the State. If approved, Proposition 5 will authorize the District to levy the following excess taxes, on all taxable property within the District, as provided in Resolution No. O-20:

This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, for support of educational programs and operations expenses not funded by the State:

**Replacement Capital Levy for Educational Technology, Health and Safety Improvements**

The Board of Directors of Camas School District No. 117 adopted Resolution No. 20-06, concerning a proposition to finance educational technology, health and safety improvements. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, to acquire, install and modernize educational technology equipment, infrastructure and systems and provide technology support, modernize fire protection systems, and replace or repair boilers, roofs and other equipment:
