| CCPH Staffing and Program Updates (10 minutes) 9:45 – 9:55 | New Field Inspector started June 12 to backfill the position vacated by retiree retired. Anticipated release for independent inspections around October. Many department programs finished an internal physical move to occupy a smaller footprint. Office space utilized by food safety will be shared space, no individual desks. Temporary event season in full swing L&I placarding requirement smoother than in previous years Applicant report L&I review times spanning 4- 6 months. L&I review for mobile units involve many codes relating to safety (gas systems, fire suppression, ventilation systems, electrical, etc.) No reciprocity option Plan reviews very heavy, 30 – 40 assigned to each plan reviewer (~ 25 more ideal). Plan review ~60% higher than projected for 2024. Even with this very large volume, first review comments provided within 3 weeks of submittal is at 74%. Inspections: conducting ~300/month. Plan review staff have provided plan review "how to" sessions at Fourth Plain Forward (FPF promoted). There have been 2 Spanish, and 2 Enlish presentations. Plan review staff offering in-person office hours at the Fourth Plain Community Commons twice each month throughout the rest of the year. Some are focusing on training and policy to assist with faster and easier onboarding and training. Trying to impress taking food safety seriously. Successes CCPH presence at vendor meetings has proven helpful |
| Fee Schedule (2025) Review (15 minutes) 10:15 – 10:30 | Fees increases throghout. Primary factors are volume and results of a county-wide wage assessment. 2024 work volume exceeded projections. With even modest projections for 2025 more staff are needed in both plan review and inspection. 2025 fee schedule includes adding two additional positions (volume projections indicate 4 are needed). The program is 100% fee supported. Only 2 FTE positions in the program support "greater good"/non-fee generating work that is not specifically associated with plan review or standard inspections.
