2.	Does the County anticipate a potential increase in contract utilization for this next cycle?	There is no guarantee that of any expenditure on these contracts. Individual tasks are assigned as project needs are identified
3.	Number of task orders awarded for AREA 1: Hydraulic Engineering for the last cycle?	Firms will be used on an as-needed basis to assist with projects when county staff does not have expertise or availability to do the work. The County has not utilized the Hydraulic Engineering contract for the last cycle to date.
4.	Total dollar value of awards for Hydraulic Engineering for the last cycle?	The County has not utilized the Hydraulic Engineering contract for the last cycle to date.
