Understanding the needs, current efforts, and gaps.

- Red Cross information sharing on role and efforts related to the homeless population.
 - o Presented by Derek Chinn and Jonathan Seibert, Red Cross SW Washington Chapter
 - Derek Chinn came in hoping to better understand and gain some knowledge of how to better handle
 the houseless population after a disaster and take the information back to him team to put a plan in
 place.
 - The subgroup summarized the main issues:
 - The past year was the first year our Faith Community was not able to step in and provide as they have done in the past.
 - We invited Reds Cross to the table to learn your scope of work and how can we work together during these crises.
 - Our Homeless Crisis response System does not receive much funding to support heat, severe weather, and smoke etc.... and we wanting to learn how to create a better system.
 - Res Cross only mobilizes when they are contacted by the County.
 - Question from ECHO to Red Cross
 - What kinds of resources do you provide when preparing for disasters during the in between of disasters.
 - Presentations and trainings, such as field guide training on how to set up your own shelters.
 - Capacity building with organizations; understanding what we are facing and what's the scope of what people are facing and how do we interface with that
 - How does the County make sure the right connections are in place before a disaster happens?
 - Asking the Faith Community and Neighborhoods to help as volunteers to mobilize.
