#### 3) FIP Updates - Justin Collell

- a) Clark County Fair Justin shared a photo of the booth, new display personalizes staff, fewer angry people so far, bad location/would rather be by CPU or the plant sale, Justin introduced Alyssa Hebron who is in training
- b) Garlic mustard Now going to seed, Justin looking at fines, City of Camas hired a contractor and they have completed a lot of work, discovering new satellite patches such as the City of Battle Ground, seeds are distributed by deer, people (seeds are so small they get stuck in the mud on shoes)
- c) Poison hemlock Now gone to seed, BNB compliant
- d) Tansy ragwort In full flower and some has gone to seed, Tansy signs are out, No Larch crew due to closure, Quick capture data sent to WSDOT, 5,637 lbs. of flowerheads removed from roadsides so far
- e) Variable-leaf Milfoil Completed treatment of seven sites with initial results looking good, looking forward to the 'after' photos and may get drone footage, EDRR Training will be provided to the public on August 12, 2024
- f) Weed Free Forage No bandwidth due to VLM treatments in July, don't have capacity as we once did, No inspections this year
