- ECHO Membership by Jordan Boege
 - O He has received input on three requests:
 - Camas is interested in a police drug reading devise.
 - Andy requested that we look into additional state investment in the housing trust fund, this would be a capital budget request.
 - VHA has requested all our member jurisdictions, that would let VHA operate within their jurisdictions.
 - Tyler Chavers is interested in pursuing some expansion of assisted outpatient treatment.

City of Vancouver Homelessness Emergency Situation Report Overview

- Presented by Jamie Spinelli, City of Vancouver
 - O Jamie stated that the Washington Low Income Housing Alliance is having a policy forum locally on October 24th, at the Fourth Plain Community Commons from 5:30 -7:30pm, this information is located on their website.
 - o Reporting period on the Homelessness Emergency Situation Report Overview is August 2024:
 - 34 people have deceased
 - As of July 8th, VPD reported: 2400+ events related to unsheltered homelessness (13.6% of calls for service)
 - Hart Patrol did their usually cleanups, in addition to the East part of town, Burnt Bridge Creek Trail,
 Arnold Park, Marine Park, and their regular coordination with WSDOT.
 - o They removed 39 tons of solid waste from public property.
 - o Responded to 125 app submission on the My Vancouver App.
 - o From the safe stays and safe parks, they had 12 exits to housing.
 - o They are receiving an increase with individuals with high medical needs.
 - O They completed the requests for proposals for the Bridge Shelter Operator that opened on August 20^{th} and ended September 11^{th} and should have a contracted provider for the bridge shelter within the next few weeks.
 - o A request for qualifications for design and engineering will be closing in the next week.
 - o First phase of community engagement of the Bridge Shelter began, people can visit the "Be Heard Vancouver" page (https://www.beheardvancouver.org) to ask questions/comments.
 - Currently they are solidifying virtual and in-person community engagements surrounding the Bridge Shelter, in early to mid-November.
 - o Community Court received a donation of \$25,000.00 from Devine Design!
 - o There have been several people that have graduated.
