RFP #911 EMS SYSTEM ASSESSMENT QUESTIONS and ANSWERS UPDATED: DECEMBER 26, 2024

	QUESTION	ANSWER
1.	In selecting Option A for continuance of ambulance service under the Vancouver agreement for 1 year, has ESD2 incurred any costs related to the provision of ambulance service in the District?	No, there is no cost to the District for selecting Option A.
2.	To assist with the development of potential service delivery options, in addition to dispatch/response data, is the ESD be able to provide data related to ambulance response volume in the district that includes service mix (ALS/BLS, Emergency/Non- Emergency), and payer mix (Medicare, Medicaid, Commercial, self-pay, facility, etc.)?	This information is available and can be provided to the successful proposer.
3.	Can the ESD provide a copy of the current Clark County Ambulance Service Plan (ASP)?	The City and County does not have an ambulance service plan. The expectations are outlined in the contract. (See Attachment E)
4.	 Items C and D in the Scope of Work seem applicable only if the public policy decision is made to competitively select and contract for ambulance services for the ESD. If an adopted policy recommendation does not include a competitive RFP and provider selection, would these sections of the Scope be waived? a. As such, should costs for those components of the proposal be separately identified? 	Yes, if sections C and D in the Scope of Work are not deemed to be needed, they will be waived.a. The proposer has the option to separately identify these costs, if they choose.
5.	 Part 1, Section 3 Scope of Project, c. a. Contractor will "Develop" a competitive RFP. We can develop this RFP, but do not have the authority to offer, will the EMSD2 be the authority offering and distributing the RFP? 	Yes, if that is the consultant's recommendation, EMSD2 will offer and distribute the RFP.
6.	 Part 1, Section 3 Scope of Project, d. a. Facilitate the Contract Negotiations. Will EMSD2 be the responsible entity for final negotiations and authority to enter into a contract? If not, whom? b. Transition of ambulance providers can be facilitated, but will EMSD2 maintain ultimate responsibility? If not, whom? 	 a. Yes, if that is the consultant's recommendation for EMSD2 to be the entity to contract for ambulance service. b. Yes, if that is the consultant's recommendation. For example, if the recommendation is a fire- based model, it would be the fire based model's responsibility.
