Report Back on Action Items

- Potential state budget deficit impacts & advocacy opportunities
 - Jordan Boege stated the Department of Commerce reached out and advised all their grantees to prepare for (up to) a 20% deduction in funding the next biennium.
 - Per Michael Torres service providers are working on those projected budgets reductions. This is to take effect July 1, 2025, through June 30, 2027.
 - Jordan Boege will draft a letter/template for individual jurisdictions to be sent to the legislation opposing further cuts from the document recording fees, as well to draft a letter from ECHO as an organization.
- Camas cold weather shelter update
 - Steve Hogan stated that in looking for Cold Weather Shelters there are limited buildings, the best one is a Fire Department. By 2026 they could gain access to the Fire Department building section.
- CAAB update
 - Diana Perez the CAAB group has been going through Equity Training in preparation for the next funding cycles. At the last CAAB meeting there was a presentation from IMAPCT NW, discussi9on on what to plan for in January, equity training and CAAB code of conduct and bylaws, spoke about services provided, and success stories as well as some difficulties that are still being faced.
