Question #1: On sheet 12 of 28, there is shown to be a fiber optic line (noted to be protected)

running through the proposed filter vault location. Is the depth of this utility known?

What is the plan to install this vault with the apparent utility conflict?

**Answer:** It is anticipated the fiber optic line is a little bit further to the north than shown on the

plans but still potentially in conflict with the vault. Vertically, the fiber optic line is somewhere between 14 and 18 feet deep. That said, we should be fine. However, in case there is a conflict, Verizon said they could relocate it during construction in a day. So, in the contract documents, we have listed Verizon, with Ian's number, has a

utility that will need 3 days during construction.

2. Is the CDF to be used over the storm pipe that will be placed under the

sidewalk?

3. Is there any laydown yard available?

Reference: Std Detail U1, Section 1-07.24 (Last Paragraph)

Answer: 1. We don't anticipate impacting the guardrail.

2. CDF is required for all transverse crossings as per Std Detail U1 (Sht 21 of 28), and for backfills associated with exposing exiting utilities (vactor holes) that falls outside the immediate work zone area. All other locations, use granular backfill as approved by local agency or WSDOT specifications for

granular backfill.

3. The Contractor shall be responsible for providing, without expense or liability to the Contracting Agency, any additional land and access thereto that the Contractor may desire for temporary construction facilities, storage

of materials, or other Contractor needs.
