

# CLARK COUNTY STAFF REPORT



DEPARTMENT: The Arthur D. Curtis Children's Justice Center (CJC)

### **REQUEST:**

That Board of Commissioners authorizes the Professional Service Contract between the City of Washougal and the Children's Justice Center for forensic interviewing services when there is a suspicion of a child abuse crime within the Washougal City Jurisdiction.

### **BACKGROUND**

The City of Washougal is not included in the Interlocal Agreement and has not been willing to participate with the Children's Justice Center (CJC) collaborative in the past. Therefore, Washougal Police Department has completed their child abuse criminal investigations on their own and a child victim does not have access to CJC's comprehensive response system unless a case is charged during the prosecution phase. Over the years as the CJC initial response system improved significantly creating a very different quality of the initial response dependent upon where a child victim was in Clark County. If a suspected crime against a child occurred within a city jurisdictions that was not part of the CJC collaboration, the child was interviewed by a law enforcement officer outside our local accredited Children's Advocacy Center. One of the most notable differences with CJC's initial response was the use of a child-centered setting, video recording capacity, collaborative observation capacity and the use of a trained civilian forensic interviewer. For these reason, the City of Washougal seeks to pay an hourly fee for the use of CJC's center to hold the initial interview utilizing CJC's forensic interviewer.

#### **COMMUNITY OUTREACH**

A long-term effort by CJC has been, and is still in process, to develop a partnership between CJC and smaller city jurisdiction in Clark County who have not joined the CJC collaborative to ensure that all children throughout Clark County are met with a the same uniform and quality response. CJC is Clark County's nationally accredited Children's Advocacy Center and it is important for all children to have access to it's services. The City of Washougal is the first of city jurisdiction not currently a part of the CJC collaborative to create a partnership.

#### **BUDGET AND POLICY IMPLICATIONS**

The fee within this contract agreement will be paid to CJC by the City of Washougal on an hourly basis. Funding generated by this agreement will be added applied to the operating costs resulting for the additional workload.

# **Professional Services Contract**

THIS AGREEMENT, entered this \_\_\_\_\_\_ day of \_\_\_\_\_\_ 2013, by and between CLARK COUNTY, after this called "County," a political subdivision of the City of Washougal Police Department, after this called "Contractor."

## WITNESSETH

WHEREAS, Contractor would like to utilize services at the Arthur D. Curtis Children's Justice Center (CJC) for civilian forensic interviewing services for children where a crime may have been committed within Contractor's law enforcement jurisdiction, NOW, THEREFORE,

## THE COUNTY AND THE CONTRACTOR MUTUALLY AGREE AS FOLLOWS:

- 1. <u>Services</u> County shall respond as available per request from Contractor for child forensic interviewing services outlined herein in the attached reference as Exhibit "A."
- 2. <u>Time</u>. The contract shall span over an eleven-month period effective beginning in April 2013 and ending on December 31, 2013.
- 3. <u>Compensation</u>. Contractor agrees to pay County an hourly fee of \$65.00 per hour for forensic interview services in accordance with Exhibit A.

County will provide an invoice to Contractor including date of service, type of service, number of hour of service, and the client's name for forensic services provided.

Contractor agrees to compensate County's forensic interviewer for any travel off the work-site if the request for travel was made by Contractor. County's forensic interviewer will submit appropriate reimbursement forms and required documentation in accordance with Contractor's travel policies in order to receive compensation for travel associated with work performed for Contractor's clients.

- 4. <u>Termination</u>. The Contractor or County may terminate this contract for any reason upon thirty (30) days notice to the County. The County or the Contractor may terminate this contract immediately upon any breach in the duties set forth herein. A waiver by the County or Contractor of one or more breach shall not be held or construed as a waiver of any subsequent breach or breaches. Contractor shall compensate County for services expended up to the date of termination.
- 5. Indemnification: Each of the parties hereto agree to be liable for its own conduct, including without limitation breach of this Agreement, and to indemnify the other party against any and all losses therefore. In the event that loss or damage results from the conduct of more than one party, each party agrees to be responsible for its own proportionate share of the claimant's damages under the laws of the State of Washington.

County disclaims any responsibility for the safety of the workplace, and Contractor agrees to assume the risk of any injury or damage to Contractor's staff persons or party of arising out of, or related to the services contemplated under this Agreement.

6. <u>Contract Documents:</u> Contract documents consist of this agreement and Exhibit "A". Where provisions of the contract and provisions of the Proposal for Professional Services are inconsistent, the provision contained in the contract shall be

controlling.

- 7. <u>Changes:</u> County may, from time to time, require changes in the scope of the services to be performed hereunder. Such changes, including any increase or decrease in the amount of the Contractor's compensation, which are mutually agreed upon by and between County and the Contractor, shall be incorporated in the written amendments to the agreement.
- 8. <u>Governing Law.</u> This agreement shall be governed by the laws of the State of Washington. Venue for any litigation shall be Clark County, Washington.
- 9. <u>Confidentiality</u>. With respect to all information relating to County that is confidential and clearly so designated, Contractor agrees to keep such information confidential.
- 10. 15. Consent and Understanding. This agreement contains a complete and integrated understanding of the agreement between the parties and supersedes any understandings, agreement, or negotiations, whether oral or written, not set forth herein or in written amendments hereto duly executed by both parties.

11. <u>Severability</u>. If any provision of this agreement is held invalid, the remainder would then continue to conform to the terms and requirements of applicable law.

## EXHIBIT A

## Scope of Work

## **PURPOSE**

Contractor seeks to utilize County's civilian forensic interviewer services for children where an abuse crime may have been committed within their law enforcement jurisdiction.

## **SERVICES**

Forensic interview service billable hours include, but are not limited to the following:

- The initial coordination, case information exchange and assessment of any special needs or accommodations for the child
- Work involved with family members or the child's caretaker or social worker to explain what is needed and arrange for a convenient date and time for the interview
- Interview prep and rapport building with the child before the interview
- Interview and consultation with law enforcement observing the interview
- DVD creation and summary reporting
- Work involved in defense challenges of the interview
- Time involved to defend the interview during court appearances
- Travel expenses incurred when interviewing children off-site or meeting with Contractor's personnel off-site when Contractor has made the request

## **DESIRED OUTCOMES**

Certain children, or certain individuals with learning disabilities, living within the City
of Washougal jurisdiction are provided with CJC's forensic interview services
