INTRODUCTION

The property owners of certain parcels are requesting a required transportation mitigation measure be removed from an approved concomitant rezone agreement. The transportation mitigation measure proposed to be removed is:

Modify the southbound NE 23rd Avenue approach to NE 134th Street to provide either: (1)
a share left-right lane (converted from the existing left only lane) with the existing exclusive
right turn lane; or (2) an overlap phase for the existing right turn lane.

BACKGROUND

On April 21, 2015, Clark County approved an agreement and covenant to rezone certain property and require transportation mitigation measures prior to the issuance of building permits for properties identified by numbers 185796000, 185700000, 185672000, 185726000 and 185727000, which are located in the vicinity of the NE 139th Street and NE 10th Avenue intersection. The concomitant rezone agreement was approved concurrent with a Comprehensive Plan map and zoning amendment from a light industrial designation with IL zoning to a General Commercial designation with GC zoning on the subject properties. The concomitant rezone agreement is recorded by the Clark County Auditor as document number 5170404.

The Washington Department of Transportation submitted a letter, Exhibit 1, suggesting that the required mitigation at the NE 23rd Avenue/NE 134th Street intersection be rescinded. WSDOT commented that that the required mitigation would "result in the majority of right turning traffic utilizing the shared lane and potentially degrading existing operations."

COUNCIL POLICY IMPLICATIONS

The action to remove the specific transportation mitigation measure from the concomitant rezone agreement would not result in a change of the council's policies.

ADMINISTRATIVE POLICY IMPLICATIONS

The action to remove the specific transportation mitigation measure from the concomitant rezone agreement would not result in a change of administrative policies. If this proposed action is approved by Council, the existing concomitant rezone agreement would be amended to remove the specific transportation mitigation measure and re-recorded with the County Auditor.

Dear Mr. Stewart:

A condition of the Clark County Concomitant Rezone Agreement (AFN 5170404) for Skyview Station was to change the southbound NE 23rd Avenue left-turn only lane at NE 134^{rh} Street to allow a shared left and right-turn movement. The Washington State Department of Transportation's (WSDOT) interest in this intersection is because it serves as the northbound 1-205 off-ramp at NE 134th Street, ramp terminal intersection.

WSDOT does not support converting the southbound NE 23rd Avenue left-turn only lane to a shared right and left-turn lane. Since the probable destination for vehicles utilizing the proposed shared right and left-turn lane is I-205 Southbound, it is likely this change would result in the majority of right turning traffic utilizing the shared lane, and potentially degrading existing operations. Moreover, WSDOT staff has shared their concerns regarding this condition of approval with representatives from Clark County and suggested the condition be rescinded.
