

## Dear Clark County Voters

I would like to take this opportunity to thank the Clark County Board of County Commissioners as well as the other participating jurisdictions for providing the funding to prepare and mail you this Local Voters' Pamphlet. I believe the Voters' Pamphlet is one of the most important ways in which voters obtain information about candidates and issues. We are very pleased to be able to provide you with this pamphlet.

While this pamphlet is an important tool, **I urge you to seek out more information – informed voters make the best decisions.** We have provided easy access to a wide variety of on-line resources through our website at www.co.clark.wa.us/auditor/Election/On-LineRes.html.

Depending on which County Commissioner district you live in, you will find candidates for six, seven or eight Freeholders on your ballot. The elected Freeholders will be responsible for preparing a Home Rule Charter to be submitted to voters for their consideration. The Charter, if approved by voters, would define the form of county government and could also incorporate other features.

Because 11 of the 21 Freeholder positions have fewer than three candidates the outcome for these positions will be determined on September 19. The outcome of the remaining 10 positions (where three or more candidates filed and no candidate receives a majority of votes in the primary) will be determined by the General Election on November 7. In an attempt to improve voters' ability to make an informed choice among Freeholder candidates, Clark County has established a website where all Freeholder Candidates can post a statement and a photo of themselves. This website is located at www.co.clark.wa.us/site/freehold/ and can also be accessed via the website described above.

**Your vote matters!** There are numerous examples throughout history where the results of an election that was decided by just a few votes had long lasting effects on society. Locally, just during my short time in office, a candidate race was decided by one vote and a bond issue failed by six votes. This September, I hope you'll join me in voting and exercising one of the most precious rights we have as Americans – the right to vote.

Commissioners file for office by district and must live in the district in which they file. They are voted on by district in the primary and elected at large at the general election. Commissioners serve four-year overlapping terms.

## **Election of Freeholders**

This fall the voters of Clark County will be electing 21 Freeholders to draft a county charter. The citizens of Clark County are currently governed by a form of government that is defined by state law and has existed since the State was formed over 100 years ago. This form of government can be replaced with a new form of government, if the citizens of the County decide that it is to their advantage to do so. The first step in the process of changing the current form of County government is to elect a group of 21 Freeholders. Once elected, these Freeholders will have up to three years to draft a county charter, which will define how a new form of County government would function. Once the draft of a county charter is written, it will be submitted

to a vote of the citizens. If a majority of the citizens vote for approval of the new county charter the County will change its form of government. If a majority of citizens vote against approval of the new county charter, Clark County will continue with its current form of government.

The names of all fifty-two citizens who filed declarations of candidacy to run for Freeholder to draft a county charter will appear on the September 19th Primary ballot. If any candidate receives a majority of the votes cast in the Primary for the position they filed for, they will be elected and will not appear on the November 7th General election ballot. If no candidate receives a majority of votes for their position in the Primary, the two candidates with the greatest number of votes will go on to the General election ballot. After the General

election is over, the elected Freeholders will begin to meet in order to draft a county charter.

Due to space limitations in the Primary Local Voter's Pamphlet, the statements and photographs of the Freeholder candidates will not appear. ## CITY OF BATTLE GROUND Proposition No. 1 AUTHORIZING PROPERTY TAX LEVY

Shall the City of Battle Ground, Washington increase the tax levy to \$2.73 per \$1,000 assessed valuation (an increase of approximately \$.50 per \$1,000 assessed valuation), with the resulting revenues to be used for rebuilding, repair and maintenance of City Streets, collection to begin in 2001?

#### Better Roads for Battle Ground!

The simple truth is that street repair needs are outstripping the availability of state or federal funds. Miles of existing arterial streets, old roadways, and neighborhood streets need paving to upgrade or preserve the street system. Good maintenance today will save our streets from further decay and prevent future costly repairs.

### A Clear Choice

You can stop the deterioration of our roadways or face a future of potholes and rough roadways. The city is requesting a .50¢ property tax levy that would dedicate \$250,000 a year to paving projects within the city limits. 70% of these funds would be directed to arterial repairs with the other 30% going to maintain neighborhood streets.

#### Good Tax News

Battle Ground has the lowest general fund tax rate in Clark County at \$2.23 per \$1,000 evaluation of your property. Since 1991, the property tax rate has dropped from over \$5.30 to \$2.65, a 50% decrease. A "Yes" vote will still keep Battle Ground property tax rate as one of the lowest in Clark County.

## Explanatory Statement of the ballot measure

Under current statutes a city has the capacity to levy up to \$3.10 per \$1,000 of assessed valuation for taxes. As recently as 1991, Battle Ground's rate was \$2.81 per \$1,000. Because of various statutory limitations the current rate has been forced down to \$2.23 per \$1,000. The city seeks voter approval to exceed the limitations set forth in RCW 84.55 and increase the rate back up to \$2.73 per \$1,000, an increase of approximately fifty cents per \$1,000 of assessed valuation. The resulting increase in revenues is to be used for repairing, rebuilding and maintaining city streets.

## Statement for:

Medical emergencies now comprise about 80 percent of all 9-1-1 calls in Clark County. For Fire District 5, this amounted to nearly 14,000 responses in 1999.

Fire District 5, through a service contract with Vancouver Fire Department, provides prompt response to medical emergencies.

The Board of Fire Commissioners is asking voters to authorize an Emergency Medical Services (EMS) levy in the amount of 20 cents per \$1,000 of assessed valuation. This translates to \$30 per year for the owner of a \$150,000 home over a six-year period. It is essential and necessary for the protection of the health and life of residents of the district.

The funds will be used to: (1) Augment paramedic/EMT staffing; (2) Provide on-going, mandated medical training for paramedics and Emergency Medical Technicians (EMTs); and (3) Purchase additional equipment such as heart monitors used to treat heart attack victims.

Highly-skilled paramedics deliver Advanced Life Support at medical emergencies within the first few minutes. Because of their superior medical training and certification, paramedics are able to assess critical medical emergencies and perform life-saving procedures and administer medications.

The proposition on the September ballot will allow the Fire District to ensure that well-trained and equipped paramedics arrive on the emergency scene during the first critical minutes after the 9-1-1 call.

We urge a Yes vote on September 19.

## **Statement for:**

Forty years ago this Spring, Fire District #9 started providing emergency fire service to the communities in and around Fern Prairie including Ammeter, Ireland, Livingston, Sunnyside, Washougal River Road, and Woodburn Hill. In those early years there was minimal equipment and 50 dedicated volunteer fire fighters. They responded to 18 calls the first year. Today, F.D. #9 has 30 dedicated volunteers responding to approximately 400 emergency calls a year and a tax base that will not yet support career fire fighters.

In January, an Advisory Task Force made up of Fire Commissioners, Fire Fighters, and Citizens began "Project 2000" to plan for the next 20 years of service to the community. A plan was produced to methodically replace worn out and outdated personal protective equipment, facilities, and fire apparatus over the next twenty years.

Existing equipment has been reviewed and scheduled for replacement based on age, repair history, and parts availability. At least \$4,000,000.00 will be required to replace the oldest equipment and fire apparatus in addition to building a fourth fire station in the Lessard Road area as call volume increases. The District's oldest in service fire apparatus is 46 years old and not economically feasible to maintain for the value it provides.

Fire District #9's biggest challenge for this millennium is recruiting, training, and maintaining volunteer fire fighters in accordance with all the state mandated requirements that often arrive not funded. As a community member, please vote *Yes* for support of *your* volunteer fire district.

## Statement for:

Medical emergencies now comprise approximately 80 percent of all 9-1-1 calls in Clark County. For Fire District 11, this amounted to nearly 1,300 responses in 1999.

The Board of Fire Commissioners is asking the voters to authorize the addition of Paramedic services by approving an EMS levy in the amount of 25 cents per \$1,000 of assessed valuation.

Paramedic/Firefighters provide a significant enhancement to the services provided by assuring Advanced Life Support arrives at a medical emergency within the first few minutes of the 9-1-1 call. Paramedics are able to better assess life threatening medical emergencies, stabilize critical patients until transported to the emergency room, perform specialized life-saving procedures, administer medications and utilize specialized cardiac heart monitors.

The funds will be used to: (1) Hire 3 Paramedic/Firefighters to staff the main station at Dollars Corner, 1 for each of the three shifts; (2) Purchase new cardiac heart monitors used to treat heart attack victims; (3) Purchase necessary medical equipment and supplies; and (4) Provide on-going medical education/training.

The proposition on the September ballot will allow the Fire District to assure that properly trained and equipped Paramedics arrive on the emergency scene during the first critical minutes after the 9-1-1 call. We urge a *Yes* vote on September 19.

Emergency Medical Services is one of the many benefits that we as a community need and deserve. When the call goes out you want the best-trained best-equipped personnel responding to your family, your neighbors, or yourself? And just as importantly, you want them to respond in the fastest possible time. The levy that is put before you will do just that. Funds collected will be used to train and equip Fire Protection District #14 personnel as Paramedics and add them to the existing Emergency Medical Technicians. It will enable them to be stationed within Fire Protection District #14 boundaries instead of responding from Vancouver, Battle Ground or Yacolt. Currently the citizens of the district could wait as long as 40 minutes for a paramedic. These funds would also be used to provide life saving heart monitors, medications, and equipment, as well as the training and continued training to maintain highly skilled Paramedic care. WHEREAS, the additional revenues received as a result of the increase in the general expense fund tax proposed herein would be dedicated to the rebuilding, repair and maintenance of City streets; and,

WHEREAS, it is the conclusion of the City Council of the City of Battle Ground that it is necessary and appropriate to call for an election and submit to the voters of the City the following proposition;

A RESOLUTION of the Board of Commissioners of Clark County Fire Protection District Number 14 providing for the submission to the qualified electors of the District at a special election to be held within the District on September 19, 2000, in conjunction with the state primary election to be held on the same date, of a proposition authorizing a levy of a property tax not to exceed \$.50 per \$1,000.00 of true and assessed valuation in addition to its regular property tax levy, each year for a period of six (6) consecutive years, to be levied each year beginning in 2000, to provide funds required by the District to enable the District to improve Emergency Medical Services (EMS).

BE IT RESOLVED BY THE COMMISSIONERS OF CLARK COUNTY FIRE PROTECTION DISTRICT NUMBER 14 AS FOLLOWS:

WHEREAS, it is the judgement of the Board of Commissioners of District 14 that it is essential and necessary for the protection of the health and life of the residents of the District that Emergency Medical Services be improved by the District. Such improvements shall necessitate the expenditure of revenues for contract services, maintenance, and equipment in excess of those which can be provided by the District's regular tax levy for collection over the next six years beginning in 2001.

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of Clark County Fire Protection District Number 14 as follows:

Section 1. In order to improve medical services, it is necessary that the District perform the following functions:

- 1.1 Obtain and maintain a transport and/or medical aid vehicle.
- 1.2 Obtain consumable Advanced Life Support (ALS) medical supplies and ALS appliances to equip such vehicles.
- 1.3 Obtain paramedic services through a contract with other municipal corporations.

Section 2. In order to provide the revenue adequate to pay the costs of providing this improved EMS as described in Section 1 and to maintain reserve funds sufficient to assure the continuation of such services, the District shall levy each year for a period of six consecutive years, beginning in 2000, and collect each year for a period of six consecutive years, beginning in 2001, a general tax on taxable property within the District, in addition to the regular levy for maintenance and operation cost, in an amount not to exceed \$.50 per \$1,000.00 of assessed valuation of such property. The amount to be levied in 2000 and collected in 2001 is approximately \$60,000.00.

Section 3. In accordance with RCW 84.52.069 the funds raised by such levy shall be used only for the provision of emergency medical services, including related contract cost and related equipment, supplies, vehicles, and structures needed for the provision of EMS. Section 4. There shall be submitted to the qualified electors of the District for their ratification or rejection, at a special election on September 19, 2000, in conjunction

with the state primary election to be held on the same date, the question of whether or not such levy for improved emergency medical services, in addition to the regular levy for maintenance and operation, shall be made each year for a period of six consecutive years, the first levy to made in 2000 and to be collected in 2001. The Board of Commissioners hereby requests the auditor of Clark County, as ex-officio Supervisor of Elections, to submit the following proposition at such election, in the form of a ballot title substantially as follows: (see Fire Protection District No. 14, Proposition No. 1).
