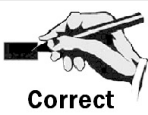

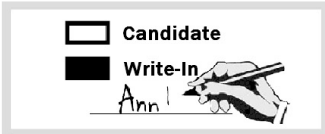

Use a blue or black pen to completely fill in the box to the left of your choice.

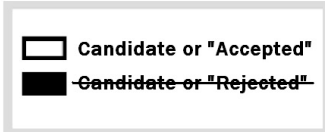
Vote for one choice for each office or ballot measure. If you vote for more than one choice for that office or ballot measure, no votes will be counted for that contest or ballot measure.

Town of Yacolt
Proposition No. 1
 Emergency Medical Program Excess Levy

The Town Council, Town of Yacolt, Clark County, Washington, adopted Resolution No. 505, referring to the voters the proposition described herein. This proposition allows the electors of the Town of Yacolt to authorize a one-year excess levy to be made in 2014 for collection in 2015 of \$112,260 at an approximate tax rate of \$1.50 per \$1,000 of assessed valuation, with the proceeds of such excess levy to be used for maintenance, operation and staff salaries for the North Country Emergency Medical Service for an estimated three (3) year period.

Proposition No. 1
 Emergency Medical Program Excess Levy

The Board of County Commissioners of Clark County, Washington adopted Resolution No. 2014-04-12, referring to the voters the foregoing proposition. This proposition allows the electors of Clark County Emergency Medical Service District No. 1 to authorize a one-year excess levy to be made in 2014 for collection in 2015 of \$1,609,025 at an approximate tax rate of \$1.50 per \$1,000 of assessed valuation, with the proceeds of the excess levy to be used for maintenance, operation and staff salaries for the North Country Emergency Medical Service for an estimated three (3) year period.

WHEN RETURNING YOUR BALLOT

Before mailing your ballot, check the pick-up schedule on the mail box and confirm there will be another scheduled pick-up on election day.

If you return your ballot to a drop site location, it must be returned by 8:00 PM on Tuesday, August 5, 2014, for it to be counted.
