## NOTE TO VOTERS

This sample ballot contains all candidates who have filed for office and will appear in the Primary and Special election on August 16. You will **not** be entitled to vote on all races and issues that appear on this ballot. When you vote only the candidates and local measures that apply to your precinct will be listed on your ballot.

For the August 16, 2011 Primary and Special election, some registered voters in Clark County will not have any candidate races or ballot issues on which to vote. They will not be receiving a ballot for this election.

Ballot deposit locations are open from 7 AM to 8 PM, election day only.

### **MAKE SURE YOUR VOTE COUNTS.**

Before you begin voting, please take the time to read through all of the voting instructions printed on the ballot you receive and the instructions printed on the other materials included in your ballot packet. By taking the time to understand the voting instructions for this election thoroughly you will make sure your vote counts.

#### **Voting Instructions:**

- 1) Your ballot must be voted in secret and shown to no one.
- 2) Use a black or blue ink pen to mark your ballot by completely filling in the box to the left of your choice(s).
- 3) Vote for only one choice for each office or ballot measure. Unless specifically allowed by law, more than one vote for an office or ballot measure will be an overvote and no votes for that office or ballot measure will be counted.
- 4) To vote for a person not appearing on the ballot, completely fill in the box to the left of the "Write-in" choice and use the line provided for their name.
- 5) If you make a mistake when voting, completely cross out the name of the candidate or choice you do not want. You then have the option of making another choice.

#### CLARK COUNTY EMERGENCY MEDICAL SERVICE DISTRICT #1

##### PROPOSITION NO. 1 EMERGENCY MEDICAL PROGRAM EXCESS LEVY

The Board of County Commissioners of Clark County, Washington, as governing body for the Clark County Emergency Medical Service District No. 1, adopted Resolution No. 2011-05-16, referring to the voters a proposition to allow the electors of Clark County Emergency Medical Service District No. 1 to authorize a one-year excess levy to be made in 2011 for collection in 2012 in the total amount of \$1,226,935, at an approximate tax rate of \$1.10 per \$1,000 of assessed valuation, with the proceeds of such excess levy to be used for maintenance, operation and staff salaries for the North Country Emergency Medical Service for an estimated three (3) year period. Should this tax levy be approved?

#### PROPOSITION NO. 1 EDUCATIONAL PROGRAMS AND OPERATIONS LEVY

The Board of Directors of Mount Pleasant School District No. 29-93 adopted Resolution No. 2010-11-10, concerning a proposition to finance educational programs and operations expenses. This proposition would authorize the District to levy the following excess taxes, on all taxable property within the District, for support of the District's General Fund educational programs and operations expenses:
