This proposition authorizes the District to construct and equip a new high school and convert the existing high school to a middle school; issue \$49,500,000 of general obligation bonds maturing within a maximum term of 21 years; and levy property taxes annually, in addition to regular tax levies, to repay such bonds, all as provided in Resolution #2005-08.
