

Auditor's letter

Dear Clark County Voters

Your locally prepared and funded Voters' Pamphlet contains information about most candidates and local measures, on your primary ballot. The Secretary of State's website www.secstate.wa.gov/elections has an online voters' pamphlet with additional information on federal, legislative and judicial candidates.

Another excellent source of information is provided by CVTV, which produces a Video Voters' Guide, conducts candidate interviews, and replays candidate forums. These are broadcast on Channels 21 and 23 and online at http://cvtv.org.

Many ballots cannot be delivered by mail to voters who have moved and have not updated their addresses with the Elections Department. If you move, please provide your new address to the Elections Department by calling (360) 397-2345, by e-mail to elections@clark.wa.gov, or online at www.clarkvotes.org.

You may mail your ballot or take it to a "drive-up" ballot box in downtown Vancouver, one block east of Franklin Street in the center of 14th Street, about one block from the Elections Department. The box will be available from July 28 through August 17. The box will close at 8 p.m. on August 17.

Another option is to deliver your ballot on August 17 to one of 33 secure, staffed ballot drop-off boxes located throughout the county. Locations where you can drop off your ballot that day are listed on page 9.

If you are a registered voter and have not received your primary ballot in the mail by Friday, August 6, please contact the Elections Department to obtain a replacement ballot.

To make sure your vote is counted, please use a black or blue ink pen to fill in the box by your choices. If you make a mistake, please contact the Elections Department to ask for a replacement ballot, or refer to instructions included with your ballot.

I urge you to read this pamphlet but to also seek out more information. The best decisions are made by informed voters.

A reminder to vote

Registering to vote

Registering takes only a few minutes, and you may do it by mail or online at www.clarkvotes.org. You must complete a voter registration form if you are registering for the first time in Washington or if you moved to a new county. If you



have moved within the same county, you may complete a new form or contact the Elections Department by mail, e-mail or phone. Registration forms are available during business hours at public libraries, schools when they are open, city and town halls, and the County Elections Department.

Who is eligible to vote

The requirements for registering to vote are simple. You must be a United States citizen, 18 years or older on August 17, and live in Clark County 30 days prior to the election.

How to vote

Clark County voters will receive their ballots by mail. If you are a registered voter in Clark County, we will mail you a ballot for every election in which you are entitled to participate.

The page **Voting instructions** (page 10) in this pamphlet explains how to vote using the Clark County voting process. Please read the instructions in this pamphlet. We want your vote to count!

Lost or damaged ballot?

If you lose your ballot, or it becomes damaged, you can obtain a replacement ballot by contacting the Elections Department.

Top 2 Primary FAQs

From the Washington Secretary of State Sam Reed

What does this mean for voters?

In August 2010, the state will conduct a Top 2 Primary. Voters will not have to pick a party and will be able to choose among all candidates for each office. In each race, the two candidates with the most votes will advance to the general election.

What is a Top 2 Primary?

A Top 2 Primary allows voters to choose among all candidates running for each office. Voters do not have to declare a party affiliation in order to vote in the primary.

Candidates for partisan office may state a preference for a political party, which is listed on the ballot. Candidates do not have to be supported, nominated or endorsed by that party. The two candidates who receive the most votes in the primary qualify for the general election. Candidates must also receive at least 1 percent of the votes cast in that race in order to advance to the general election.

What does the candidate's "party preference" mean in a Top 2 Primary?

Each candidate for partisan office may state a political party that he or she prefers. A candidate's preference does not imply that the candidate is nominated or endorsed by the party, or that the party approves of or associates with that candidate.

How did the Top 2 Primary become law?

The Top 2 Primary was passed by the people in 2004 as an initiative. I-872 passed by almost 60 percent.

What happened after I-872 passed?

In May 2005, the state Democratic, Republican and Libertarian parties sued in federal court to prevent its implementation. The political parties argued that the Top 2 Primary system violated their right to free association.

The federal District Court agreed with them and issued an order in July 2005 prohibiting the state from implementing the Top 2 Primary. The state appealed, but the Court of Appeals also agreed with the parties in an order issued in 2006. The state appealed to the U.S. Supreme Court.

What did the U.S. Supreme Court decide?

The court upheld the constitutionality of I-872. The Supreme Court reasoned that, since this form of primary has never been used, the political parties' challenge was based on assumptions. The court decided that it would not nullify the vote of the people based on speculation.

Could a race in the general election include two candidates who prefer the same party?

Yes. The candidates in each race who advance to the general election will be the two who receive the most votes in the primary. It is possible that both candidates who advance to the general election prefer the same party.

Can a voter still write-in a candidate?

Yes. Each race on the ballot will still have a write-in line and you can write in the name of a candidate.

What offices are affected?

The Top 2 Primary applies to elections for partisan office. This includes the U.S Senate and House of Representatives, the State Legislature, partisan statewide offices such as Governor, and partisan county offices such as County Commissioner or County Treasurer.

The Top 2 Primary does not apply to elections for president and vice president, or nonpartisan office such as judicial office, municipal office, or a junior taxing district such as fire district or school board.

Does the U.S. Supreme Court opinion impact the presidential primary?

No. The Top 2 Primary is for local, state and Congressional races. The presidential primary is a separate system that only applies to nominating candidates for president, and how the major parties allocate their delegates to the national conventions. The relevant statutes are RCW 29A.56.010 through RCW 29A.56.060.

Where can I find more information about the Top 2 Primary?

Questions from candidates

What does this mean for candidates?

Candidates must still file a declaration of candidacy with the County Auditor or the Secretary of State, depending on the office. Candidates will be allowed to state on the declaration of candidacy which political party they prefer, and that information will be listed on the ballot.

This is strictly an expression of that candidate's preference. It does not imply that the candidate is nominated or endorsed by the party, or that the party approves of or associates with that candidate. For purposes of conducting elections, people running for office are not members of a particular party or candidates of a particular party. Rather, they are candidates running for office, and are provided the opportunity to express a preference for a political party.

Are minor party candidates still required to conduct conventions and collect signatures in order to run for office?

No. All candidates use the same procedures to file for office and appear on the primary ballot. The Top 2 Primary evens the playing field for candidates. Candidates may list any party as the party that they prefer.

Minor party and independent candidates for president and vice president are an exception. They must still collect signatures and obtain the consent of the candidates.

Can the political parties prevent a candidate from expressing a preference for their party?

No. Candidates are permitted to express a preference for any political party. The court ruled that the ability of candidates to express a preference for a party does not severely burden the rights of the party.

Can the political parties still nominate candidates?

Yes. State law no longer dictates how political parties conduct their nominations. Now, the state and local parties decide how to conduct their nominations. The rules for party-run nominations vary party to party, and even between the state and local parties. Political parties can nominate multiple candidates for the same race. The court stated:

Whether parties nominate their own candidates outside the state-run primary is simply irrelevant. In fact, parties may now nominate candidates by whatever mechanism they choose because I-872 repealed Washington's prior regulations governing party nominations.

Can the political parties demand that their nominees be distinguished on the ballot?

No. The law does not allow nominations or endorsements by interest groups, political action committees, political parties, labor unions, editorial boards, or other private organizations to be printed on the ballot.

The Supreme Court ruled the political parties do not have a constitutional right to have their nominees distinguished on the ballot. The Supreme Court said:

"It is true that parties may no longer indicate their nominees on the ballot, but that is unexceptionable: The First Amendment does not give political parties a right to have their nominees designated as such on the ballot. ... Parties do not gain such a right simply because the state affords candidates the opportunity to indicate their party preference on the ballot. "Ballots serve primarily to elect candidates, not as forums for political expression."

Can candidates advertise themselves as nominees of a political party?

Yes. Candidates can promote themselves in voters' pamphlets, advertisements, and other forums as the nominees of a political party.

After candidate filing week, can a major party fill vacancies on the major party ticket?

No. This process was specifically repealed in I-872 because there is no major party ticket in a Top 2 Primary. All candidates are treated the same.

A race will only be reopened for a special filing period if there is a void in candidacy, meaning no candidates filed during the regular filing period.

If only one or two candidates file, will that race skip the primary and only appear on the general election ballot?

No. Even if only one or two candidates file for a partisan office, that race will still appear in the primary. It is only in nonpartisan elections that the race skips the primary when just one or two candidates file. The relevant statute is RCW 29A.52.220.

If a candidate for partisan office who was one of the top two vote-getters in the primary dies or is disqualified before the general election, will the party be allowed to name a replacement?

No. In a Top 2 Primary, a candidate's party preference is purely for informational purposes and does not play any role in the administration of the election. Because the candidates are not representatives or nominees of a political party, a party is not allowed to name a replacement candidate. The laws that previously allowed the political parties to replace deceased or disqualified candidates were repealed in I-872.

If you wish to return your voted ballot in person before the primary, August 17, take it to the:



1408 Franklin Street, Vancouver. 8 a.m. to 5 p.m. Monday through Friday. If you lose your ballot or it becomes damaged, you can obtain a replacement ballot only at this location.

■ Red permanent ballot drop box

West 14th and Esther streets, Vancouver (one-half block east of the Elections Department). Available 24 hours a day.

Election Day is Tuesday, August 17, 2010. If you wish to return your voted ballot **in person on Election Day** take it to the red ballot drop box before 8 p.m.


- An instruction sheet that explains the voting process.
- The official ballot where you will mark your choices (it will be folded).
- A yellow secrecy envelope with instructions printed on it.
- A return affidavit envelope with green stripes that is addressed to the county Auditor.

To make sure your vote is counted please follow the steps below when you receive your ballot package.

- Read the following instructions that explain how to vote in this election.
- Unfold and read the ballot. It contains all the races and ballot measures that you can vote.
- Mark your ballot by completely filling in the box to the left of your choice with a black or blue ink pen.



One candidate has been marked in each race and the box is filled in completely.



Optional. If you want to vote for a candidate not appearing on the ballot, completely fill in the box to the left of the Write-In choice and use the line provided. If you cast a write-in vote for a Precinct Committee Officer, be sure to include the candidate's political party.

Check your ballot to be sure you have voted for all the candidates and measures you intended. Make sure you voted for only one candidate in each race. If you vote for more than one candidate, your votes in that race will be rejected. Your other votes will be counted if they are done correctly.



Refold the ballot in the same way you received it and place it inside the yellow secrecy envelope.

Then seal it. Don't write on this envelope.

- Place the yellow secrecy envelope into the white affidavit envelope with green stripes.
- Read the oath on the affidavit envelope, and then sign and date it.
- Seal the envelope and put a first class stamp (44¢) on the envelope and mail it so it is postmarked no later than August 17.

Fire protection districts within Washington State have the authority to provide emergency medical services to the citizens of their district. To fund these services, a special six year levy is authorized and may be collected if approved by the voters of the fire district. Explanatory statement

RCW 84.55 allows Fort Vancouver Regional Library District (FVRL) to collect up to \$0.50 per \$1,000 of assessed property value per year for general operation and maintenance. FVRL has collected at a rate below \$0.50/\$1,000 since 2002 due to tax limitation laws. Passage of this proposition would restore FVRL's levy rate to \$0.50/\$1,000 for 2011. Thereafter, FVRL's levy rate would be subject to all applicable tax limitations, including the \$0.50/\$1,000 constitutional maximum and the 1% limit on annual property tax collection increases. Additional revenue collected in 2011 would be used to purchase more books and other items for check-out, and to restore library hours.

But our library district – one of our most important resources for livable and healthy communities – can't meet this dire need because of severely reduced revenues. It's been forced to make deep cuts: slashing hours at seven libraries, reducing staff by 10 percent and eliminating some popular services. Its book-buying power has been flat for more than 10 years, falling far behind growing demand and resulting in long waits for books.

Restoring the levy rate of \$0.50 per \$1,000 assessed valuation means an eight-cent rate increase -- a small amount for a big improvement throughout the district. Without approval, there's more at risk than reduced hours and inadequate numbers of books. More critical cuts are likely in the future, including one less open day a week at

the main library in Vancouver.

This is the first time in 17 years that the library district has asked voters for increased funding for operations and maintenance. The library's management and board know it's a tough time to be asking for more money. They've been good stewards of our tax money, making difficult cuts before asking us for help.

It's our choice - let's get this right! Please vote yes.

Explanatory statement

Cities within Washington State have the authority to provide emergency medical services to the citizens of their city. To fund these services, a special six year levy is authorized and may be collected if approved by the voters of the city. If the voters of City of Washougal approve this replacement levy at the rate of \$0.50 or less per \$1000 of assessed valuation at the August 17, 2010 election, the City will be authorized for the next six years to continue to collect the property tax levy necessary to provide emergency medical services.

Statement for:

This August, Washougal residents will be asked to renew the Emergency Medical Services levy, which has provided life-saving paramedic ambulance transport to everyone in east Clark County for more than thirty years. This levy is not an increase in taxes but simply the replacement of the current levy set to expire at the end of this year.

Levy History:

The EMS program, which provides an enhanced level of emergency medical services, was started in 1978. The program includes: local paramedic ambulance transport, continuous medical training for all emergency response personnel, and community training in CPR and First Aid. Residents of Washougal, Camas and East County Fire and Rescue have overwhelmingly renewed this levy for over thirty years.

Levy Assessment:

At fifty cents per thousand dollars assessed property value, the levy will provide 35 cents for paramedic responders within the community provided by the Camas Fire Department and 15 cents to Washougal Fire Department for rapid first response, which provides essential support to the ambulance crews. The funds are necessary to

support replacement of ambulances and equipment, offset rising fuel costs, continue mandated training, continue community CPR and First Aid training, and provide training and support to our firefighters and first responders.

Benefits Provided:

The levy provides funding for dual-function paramedic/ firefighters and local low-cost ambulance transport service as compared to private companies. Rapid response of a local ambulance based within the community improves patient outcomes and keeps our community safe.

Background: WHEREAS, it is the judgment of the Board of Commissioners of the District that it is essential and necessary for the protection of the health and life of the residents of the District that emergency medical services be provided by the District. The District has funded such services with an EMS levy approved by the voters in 2004 which will expire on December 31, 2010 if not renewed. Such services will necessitate the expenditure of revenues for maintenance, operations, equipment and personnel in excess of those which can be provided by the District's regular fire levy;

Resolution: NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Clark County Fire Protection District No. 6, Clark County, Washington as follows:

Section 1. In order to provide emergency medical services, it is necessary that the District perform the following functions:

- 1.1 Obtain, operate and maintain emergency medical vehicles and facilities manned by properly trained emergency medical technicians, paramedics and/or other medically trained personnel.
- 1.2 Obtain, consumable medical supplies and medical appliances to equip such emergency vehicles, personnel, and facilities.
- 1.3 Maintain and/or improve existing response levels to EMS emergencies with qualified personnel when available.

Section 2. In order to provide the revenue adequate to pay the costs of providing life protection services and facilities as described in Section 1 and to maintain reserve funds sufficient to assure the continuation of such services, the District shall renew its expiring EMS levy and levy each year for a period of six consecutive years beginning in 2010 and collect each year for a period of six consecutive years, beginning in 2011, a general tax on taxable property within the District, in addition to the fire levy for maintenance and operation costs, in a amount not to exceed \$.45 per \$1,000.00 of assessed valuation of such property.

Section 3. In accordance with RCW 84.52.069 the funds raised by such levy shall be used only for the provision of emergency medical services, including related personnel costs, service contract costs,

training for such personnel, and related equipment, supplies, vehicles and structures needed for the provision of emergency medical services.

Section 4. There shall be submitted to the qualified electors of the District for their ratification or rejection, at the primary election on August 17, 2010, the question of whether or not such levy for emergency medical services shall be renewed for a period of six consecutive years with collection beginning in 2011. The Board of Commissioners hereby requests the auditor of Clark County, as exofficio Supervisor of Elections to call such election and to submit the following proposition at such election, in the form of a ballot title substantially as follows:

Clark County Fire Protection District No. 6–Proposition #1 renewing the regular Emergency Medical Services property tax levy.

The Board of Fire Commissioners of Clark County Fire Protection District No. 6 adopted Resolution 2010-03 concerning a proposition to renew its six year Emergency Medical Services property tax levy last approved by the voters in 2004. RESOLUTION OF THE FORT VANCOUVER REGIONAL LIBRARY DISTRICT BOARD OF TRUSTEES AUTHORIZING A LEVY LID LIFT ELECTION FOR RESTORATION OF THE REGULAR PROPERTY TAX LEVY AS PROVIDED IN RCW 84.55.

A regular meeting of the Fort Vancouver Regional Library District (Library District) Board of Trustees was held May 10, 2010 at the La Center Grange and attended by a quorum of the Board for the

conduct of such business; and, after due consideration and deliberation, the following resolution was duly passed by a majority vote of all Trustees then attending.

WHEREAS, the Library District provides library services to the residents of Clark, Skamania and Klickitat Counties and the City of Woodland in Cowlitz County; and

WHEREAS, limitations imposed by Initiative 747 have caused the Library District's regular property tax levy rate to decline below the allowed maximum statutory amount; and

WHEREAS, in response to declining new revenue, the Library District in 2009 reduced its open hours by one day in each of its seven largest libraries and reduced staffing positions by 10%; and

WHEREAS, library usage continues to grow within the Library District and had increased by 8% in 2009, despite reduced hours; and

WHEREAS, the Library District has not been able to increase its book budget due to this ongoing decline in new revenue; and

WHEREAS, RCW 84.55 permits the Library District to place a measure on the ballot asking voters within its service area whether they would like to restore the Library District's levy rate to the allowable statutory limit; and

WHEREAS, a successful Levy Lid Lift election would provide the funding needed to restore library open hours that were lost in 2009 and substantially increase the book budget.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES AS FOLLOWS:

Section 1. The Board of Trustees hereby calls for a Levy Lid Lift measure to be placed on the August 17, 2010 Primary Election ballot for all voters in the library district's legal service area, at which time the proposition to restore the regular property tax levy to its allowable maximum statutory amount shall be submitted to the voters for authorization.

Section 2. The proposition, if authorized by the voters of the taxing district, will restore the library district's levy rate to \$0.50 per \$1,000 of assessed valuation.

Section 3. The ballot language shall be as follows:

The Fort Vancouver Regional Library District Board of Trustees adopted resolution 2010-5 concerning a proposition to authorize its regular property tax levy. This proposition would authorize the District to restore its regular property tax levy to the allowable rate of \$0.50 per \$1,000 of assessed value for collection in 2011 to provide continued funding for the Fort Vancouver Regional Library District's normal operation and maintenance. Resolution No. 1001

A resolution providing for the submission to the voters of the City of Washougal, a proposition authorizing the City to continue the existing Emergency Medical Services Program with a levy at the rate of \$0.50 per one thousand dollars of assessed valuation for six years (2011 through 2016).

WHEREAS, the citizens of Washougal have authorized a property tax levy of \$0.50 per one thousand dollars of assessed value for the purpose of funding an Emergency Medical Services Program for the last thirty years.

AND WHEREAS, RCW 84.52.069(5) authorizes an EMS Excess Property Tax Levy to be "used only for the provision of emergency medical care or emergency medical resources, including related personnel costs, training for such personnel, and related equipment, supplies, vehicles and structures need for the provisions of emergency medical care or emergency medical services".

AND WHEREAS, RCW 84.52.069(2) authorizes an EMS Excess Property Tax Levy of up to \$0.50 per one thousand dollars of assessed value, for duration of six years, ten years, or permanently.

AND WHEREAS, the purpose of funding the city EMS Excess Property Tax Levy at \$0.50 per thousand is to provide a safer work environment for on-duty personnel, and to provide needed emergency response personnel on-scene for any emergency the City of Washougal may have.

AND WHEREAS, the current EMS Excess Property Tax Levy expires December 31, 2010. The continuation of the EMS Excess Property Tax Levy would be collected for six consecutive years, commencing in 2011, and continuing through 2016.

AND WHEREAS, this vote would occur at a special election held on the date of the primary election on the 17th day of August 2010.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF WASHOUGAL, WASHINGTON as follows:

Section I
