Note to Voters

This sample ballot contains all candidates who have filed for office and will appear in the Primary on August 6. Only contests that apply to your precinct will appear on your ballot. For this election, some registered voters in Clark County will not have any candidate races on which to vote. They will not receive a ballot for this election. The ballot drop locations are open from 7 AM to 8 PM, election day only. Additional assistance is available to any voter who is unable to vote their ballot due to disability. Instructions

MAKE SURE YOUR VOTE COUNTS by reading the voting instructions below and those printed on the other materials in your ballot packet.

VOTING INSTRUCTIONS:

- 1) Your ballot must be voted in secret and shown to no one.
- 2) Use a black or blue ink pen to mark your ballot by completely filling in the box to the left of your choices.
- 3) **VOTE FOR ONLY ONE CHOICE FOR EACH OFFICE OR BALLOT MEASURE.** Unless specifically allowed by law, more than one vote for an office or ballot measure will be an overvote and no votes for that office or ballot measure will be counted.
- 4) To vote for a person not appearing on the ballot, completely fill in the box to the left of the "Write-in" choice and use the line provided for their name.
- 5) **IF YOU MAKE A MISTAKE WHEN VOTING,** completely cross out the name of the candidate or choice you do not want. You then have the option of making another choice.

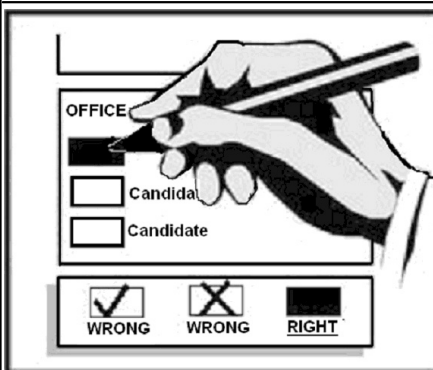
WHEN RETURNING YOUR BALLOT

If you return your ballot by mail, it must be postmarked no later than **TUESDAY, August 6, 2013.** Before mailing your ballot, check the pick-up schedule on the mail box and confirm there will be another scheduled pick-up on election day.

If you return your ballot to a drop site location, it must be returned by **8:00 PM on TUESDAY, August 6, 2013** for it to be counted.
