NOTE TO VOTERS

This Presidential Primary has unique voting requirements. Please be sure to follow them when voting.

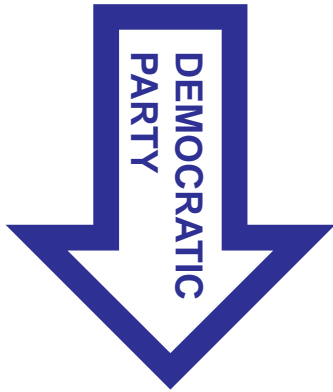
On the affidavit envelope with the green stripes included in your ballot packet there is an oath provided by each of the political parties. Each oath is followed by a checkbox. If you choose to cast a vote for a candidate seeking their party's presidential nomination, you must read the oath and place a mark in the checkbox following the oath for the party of the candidate you are choosing.

If you vote for a Democratic candidate, you must place a mark in the Democratic checkbox on the affidavit envelope. If you vote for a Republican candidate, you must place a mark in the Republican checkbox on the affidavit envelope.

If no party checkbox is marked on the affidavit envelope, your vote for any presidential nominee will not be counted. If the checkbox of one party is marked and you vote for a nominee of the other party, your vote for a presidential nominee will not be counted. If you vote for two or more nominees in one party or vote for one or more nominees in both parties, your votes for any presidential nominees will not be counted.

If your ballot contains a local measure, you can still vote on the local measure even if you choose not to vote for a presidential nominee. You must still sign the affidavit oath printed on the return envelope with the green stripes but you do not need to mark either of the party checkboxes. If you do not mark a party checkbox on the affidavit envelope, any vote you do cast for a presidential nominee will not be counted.

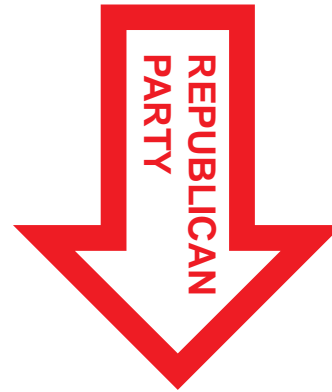

GENERAL OBLIGATION PARKS AND
OPEN SPACE BONDS

The City Council of the City of Battle Ground adopted Ordinance No. 07-021 concerning a parks and open space bond proposition. This proposition authorizes the City to develop a portion of the site at 20521 NE 112th Avenue (the Remy property) into a Little League-sanctioned sports complex with wetland mitigation; to issue its general obligation bonds in the aggregate principal amount not to exceed \$6,400,000, maturing within a maximum of 20 years; and to levy property taxes annually in excess of regular property tax levies to repay such bonds.

**REPLACEMENT OF EXPIRING SCHOOL PROGRAMS
AND OPERATIONS LEVY**

The Board of Directors of Hockinson School District No. 98 adopted Resolution No. 07-08-05, concerning a proposition to finance school programs and operations expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, on all taxable property within the District, for support of the District's General Fund school programs and operations expenses:

CAPITAL PROJECTS LEVY

The Board of Directors of Hockinson School District No. 98 adopted Resolution No. 07-08-06, concerning a proposition to finance capital projects. This proposition would authorize the District, only if Proposition 1 is approved, to acquire land, replace roof and HVAC at Hockinson Heights, replace middle school gym bleachers, acquire computers to improve instruction and carry out other capital projects, and levy the following excess taxes, on all taxable property within the District:

RESTORATION OF PROPERTY TAX LEVIES

The Board of Commissioners of East County Fire & Rescue adopted Resolution No. 77-11202007 concerning a proposition to restore its regular property tax levy for maintenance and operations to \$1.25 per \$1,000.00 of assessed valuation for collection in 2009 and thereafter subject to the limitations provided by chapter 84.55 RCW.
