




Use a blue or black pen to completely fill in the box to the left of your choice.

WHEN RETURNING YOUR BALLOT

Your ballot must be postmarked no later than election day. If you are mailing your ballot on election day, make sure you deposit your ballot prior to that day's last scheduled pick-up.

If you return your ballot to a drop site location, it must be returned by 8:00 PM on Tuesday, February 9, for it to be counted.
