This sample ballot contains **all** measures that will appear in the April 25, 2017 Special Election. Only measures that apply to **your** precinct will appear on your ballot.

For this election, some registered voters in Clark County will not have any measures on which to vote. They will not receive a ballot for this election.

Six 24-hr drop boxes are open beginning April 7 until 8 p.m. on Election Day.

Additional assistance is available to any voter who is unable to vote their ballot due to disability. Special voting equipment is available at the Clark County Elections Office for those wishing to vote their ballot without assistance.

WHEN RETURNING YOUR BALLOT

Put a first class stamp (\$0.49) on the envelope and mail it on or before Election Day, Tuesday, April 25.

Your ballot must be postmarked no later than Election Day, so check the pick-up schedule on the mailbox or confirm Election Day hours with the post office.

If you return your ballot to a drop site location, it must be returned by 8:00 p.m. on Tuesday, April 25, for it to be counted.

# Clark County Fire Protection District No. 10 Proposition No. 1

Proposition Authorizing Property Tax Levy For Fire and Emergency Response

The Board of Clark County Fire Protection District No. 10 adopted Resolution No. 2017010501 concerning a proposition to maintain and adequately fund District operations.

This proposition authorizes the District to restore its regular property tax levy to \$1.00 per \$1,000 of assessed value to be assessed in 2017 and collected in 2018. The additional funds will be used to provide full time staffing for the Fire District. The maximum allowable levy in 2017 shall serve as the base for subsequent levy limitations as provided by chapter 84.55 RCW.
