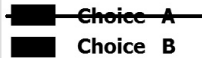

**If you return your ballot to a drop site location, it must be returned by 8:00 p.m. on Tuesday, April 25, for it to be counted.**

Proposition Authorizing Property Tax Levy For  
Fire and Emergency Response

The Board of Clark County Fire Protection District No. 10 adopted Resolution No. 2017010501 concerning a proposition to maintain and adequately fund District operations.

This proposition authorizes the District to restore its regular property tax levy to \$1.00 per \$1,000 of assessed value to be assessed in 2017 and collected in 2018. The additional funds will be used to provide full time staffing for the Fire District. The maximum allowable levy in 2017 shall serve as the base for subsequent levy limitations as provided by chapter 84.55 RCW.
