Public Involvement and Communications	Executive Team/ Communications and Public Information subcommittee on 2021 ballot measures	<ul style="list-style-type: none"> <li>• Pre-November: targeted and focused public involvement: focus groups?</li> <li>• Survey on 2022 considerations?</li> <li>• After November election: broader involvement, town halls</li> <li>• Work plan and timing critical so voters don't get confused, overloaded between 2021 ballot measures and 2022 considerations</li> </ul>
Subcommittees	<ul style="list-style-type: none"> <li>• Communications and Public Information Sub-committee</li> <li>• Select committee on Charter Review Commission legislative intent to assist code publisher on measures which pass</li> <li>• Subcommittee to debrief on results of 2021 measures</li> </ul>	<ul style="list-style-type: none"> <li>• Subcommittees on six items</li> <li>• Some subcommittees may need to research where current RCW or case law limits or restricts Charter involvement</li> <li>• Subcommittees formed August 4 and should have sufficient time to meet between full Commission meetings</li> <li>• Subcommittees to develop their own work plans and public engagement concept to report back to Executive Team and Commission</li> </ul>
Charter Review Commission	<ul style="list-style-type: none"> <li>• Informational touch points at Commission meetings</li> <li>• Scheduling speaking engagements and forums</li> <li>• Support/ schedule management by Communications and Public Information Subcommittee</li> </ul>	<ul style="list-style-type: none"> <li>• Full Commission meets first Wednesday of each month until November election, then weekly on Wednesdays until terms end December 31, 2021 (last meeting December 29, 2021)</li> <li>• Agendas to have action items</li> <li>• September: subcommittees present work plans, summarize research and concepts to date, full Commission temperature check (YES to move forward, NO means either STOP and discard or provide direction where more work is needed)</li> <li>• October: set aside for first touch of proposals, options</li> <li>• November (day after General Election): subcommittees present formalized proposals to take into public process/ town halls, Commission action on the proposals</li> <li>• December meetings: formal review of proposals, action on whether or not to place items on the 2022 ballot</li> </ul>
