2	A RESOLUTION to submit a proposition to the voters of Clark County
4	authorizing a sales and use tax of one-tenth of 1% to fund Clark County juvenile
5	detention facilities and jails, which would expire on March 31, 2032, and through which
6	allowing Clark County to fund law enforcement body worn cameras and associated
7	operational expenses.
8	WHEREAS, RCW 82.14.350 authorizes county legislative authorities to adopt a
9	Resolution providing for the submission of a proposal to the voters for a sales and use tax
10	at the next general election; and
11	WHEREAS, there is a need to increase revenue to provide critical law and justice
12	services in Clark County including body worn cameras. RCW 82.14.350 provides
13	revenue for juvenile detention and jail facilities; if Clark County has increased revenue
14	available for juvenile detention and jail facilities, then current revenue sources can be
15	made available to use for body worn cameras and associated operational expenses; and
16	WHEREAS, the purpose of the measure is to increase funding for juvenile
17	detention and jail facilities, to allow repurposing of county general fund revenue to be
18	used for all expenses associated with body worn cameras for the Clark County Sheriff's
19	Office. Such expenses include acquisition of the body worn cameras and related
20	equipment; acquisition, maintenance, and operational costs of the data storage equipment
21	needed for body worn camera footage; costs for training Clark County Sheriff's Office
22	employees as it relates to the use of body worn cameras and the camera footage; staffing

costs for additional employees needed for body worn camera data, including processing

24	public records requests and discovery requests; and additional costs due to increased
25	workload for the prosecuting attorney's office and indigent defense attorneys; and
26	WHEREAS, this matter shall be placed on the November 2021 general election
27	ballot for voter consideration; and
28	WHEREAS, the Clark County Council finds the proposal to be in the public
29	interest, and if approved by the voters, the tax shall apply within all of Clark County.
30	NOW, THEREFORE,
31	BE IT ORDERED AND RESOLVED BY THE CLARK COUNTY
32	COUNCIL, STATE OF WASHINGTON, AS FOLLOWS:
33	A ballot proposition shall be submitted to the voters of Clark County at the
34	general election in November 2021 in substantially the following form:

This tax will expire on March 31, 2032.
