Dear Clark County Neighbors,

I can't believe it's been almost two years since you elected me as your Sheriff. During this time, I have been out in the community and listening to your concerns regarding public safety. Our duty and responsibility are to keep you safe and maintain law and order. While we do this the best we can with our resources, the need for proper staffing is one resource that has been an issue for over 20 years. CCSO staffing levels are still the lowest in the state, and we need to keep up with our county's population growth. This must change to protect our community properly and for the safety of the men and women who proudly serve here.

In July of this year, I formally requested the Clark County Council to increase our staffing levels to where they desperately need to be. While no action was taken then, they expressed their support for CCSO and requested further dialogue and deliberation. In December, I will again make this request to our Council, and I hope action will be taken. I've heard your concerns about public safety, but now it's time to let our County Council hear from you directly. Please show support in requesting additional deputies for CCSO in order to keep Clark County safe.

LA CENTER POLICING CONTRACT APPROVED

The Clark County Sheriff's Office is pleased to begin providing full-time law enforcement services to the City of La Center, thanks to a formal agreement between Clark County and La Center.

On October 15th, the Clark County Council voted to approve a five-year contract with La Center. A temporary agreement for services had been in place since March.

The interagency agreement is a five-year contract in the amount of \$5,332,507, with a renewal option at the end of 2029. The City of La Center will pay for all costs associated with the new contract, which includes:

- Staffing, including one Commander (who will serve as the city's full-time Chief of Police), four Deputies, and one Support Specialist.
- The initial and ongoing cost of vehicles.
- Gear such as body cameras, protective equipment, and weapons.
- Computers and other essential equipment for operations.

The agreement also covers the costs of resources beyond patrol, such as investigations and other specialty services. All Sheriff's Office staff will be in place by February 2025.

RECRUITING INITIATIVE

I want to take a moment to update you on a crucial recruitment initiative we've undertaken to strengthen our team at the Clark County Sheriff's Office (CCSO). Recently, we launched a focused effort to bring in experienced lateral deputies from Las Vegas, based on our success with previous hires from that area. The original plan included creating a recruitment video, running a digital outreach campaign, and hosting a roadshow in Las Vegas this November.

The recruitment video was designed to showcase the beauty of the Pacific Northwest and feature testimonials from Deputies Layton and Pizan, who successfully moved from Las Vegas to CCSO. We also intended to target law enforcement officers in the Las Vegas area nearing retirement, offering them the opportunity to continue their careers in our community while enjoying a lifestyle change. While we've received positive feedback and interest from several Las Vegas law enforcement officers, we've realized that our initial timeline was a bit too ambitious. We've shifted our strategy to a more long-term approach to ensure we build the strongest possible recruitment pipeline.

Instead of rushing into the November roadshow, we're using advanced technologies like geofencing and targeted digital outreach to connect with the right candidates. This allows us to precisely reach the experienced deputies in Las Vegas who are considering relocation or retirement. We are also extending the timeline for our recruitment roadshow to potentially Spring 2025. This will give us more time to generate interest, and by the time we host in-person interviews and assessments, we'll have a larger, more qualified pool of applicants.

In the meantime, we'll continue promoting CCSO as an ideal place for deputies looking for a new career chapter. Our community's natural beauty, strong support for law enforcement, and quality of life are key selling points. The recruitment video and digital content will help us spread the word. Our goal is to bring in top talent from Las Vegas who can make valuable contributions to CCSO and help us continue providing excellent service to the residents of Clark County. We are adapting our timeline to ensure we recruit the right people in the best way possible.

Thank you for your ongoing support of this initiative. I'll keep you updated as we proceed.

Sheriff Horch hosted another town Hall on October 16th, and we were pleased to have a full-house at our West Precinct.


Attendees asked lots of great questions regarding public safety, Sheriff's Office staffing levels and the need for a new facility. Stay tuned for future Town Hall dates!

FENTANYL BUST

DETECTIVES SEIZE 11,000 FENTANYL PILLS

There are now 11,000 fewer fentanyl pills on the streets thanks to the hard work our dedicated Special Investigations Unit Detectives (SIU) and the Medford Area Drug and Gang Enforcement (MADGE) Task Force. They arrested two people for drug trafficking and seized 11k fentanyl pills concealed in their car. Over the past year, detectives learned one of the suspects frequently traveled to California to obtain large quantities of fentanyl to distribute in Clark County.

Deputies arrested a prolific retail theft suspect involved in dozens of Hazel Dell thefts. The man was wanted for more than 30 thefts in Vancouver dating back to last summer. In some of the instances, he wore a mask and used tools to cut off anti-theft devices. After spotting him in Hazel Dell in August, Dep. Gonzalez and Dep. Bylsma took the man into custody without incident. He later admitted to multiple thefts and faces dozens of retail theft charges.

DEPUTIES ARREST SUSPECT WANTED FOR MORE THAN 30 THEFTS



CRISIS AVERTED

DEPUTIES RESCUE THREE AFTER EXPLOSION THREAT; SUSPECT IN CUSTODY.

In October, Deputies took a man into custody after he threatened to blow up his shop, with several people in the home just 50 feet away. Arriving deputies quickly devised a plan, as their armored vehicle was still on the way. They positioned their patrol cars in a line in front of the home to provide cover from the shop, and a rescue team got three women out of the house and into the vehicles. The suspect then came out of the shop and surrendered without anyone getting hurt. The Metro Explosive Disposal Unit (MEDU) used a robot to clear the shop of any explosives. Investigators later found four cans of gasoline inside the shop. The suspect was booked into the Clark County Jail for Malicious Mischief Second Degree.

RETAIL THEFT MISSIONS

To combat retail theft in our area this year, the Clark County Sheriff's Office Tactical Detective Unit (TDU) teamed up with loss prevention employees at several local retail stores to conduct three successful retail theft operations. The missions resulted in 28 arrests and the recovery of several thousand dollars in stolen merchandise.

CCSO has also worked to identify and arrest high-frequency retail theft offenders, including one suspect charged with over 30 thefts. Social Media posts on these retail theft missions combating successes have been viewed more than a million times and still counting. These posts were well-received by our community and got the message out that retail theft suspects will be arrested and booked into jail in Clark County.

As a result of these efforts and the work being done daily by our CCSO Patrol Deputies, who follow up on investigations and make arrests at the stores, our local Target store in Hazel Dell leads the region in clearance rates on theft reports by a significant amount. We recently received a letter of appreciation from the loss prevention team at Target, thanking CCSO for all our hard work at their location.

Out of the roughly 100 Target stores in the region (California, Oregon, and Washington), our Hazel Dell Target store has a clearance rate of 40%. The next closest store is 21%, and the regional average is much lower at 8-10%. We are very proud of these clearance rate statistics. Although it is just a tiny glimpse of the extraordinary work being done daily by CCSO, it is an excellent example of how we all make a difference.

Target loss-prevention employees expressed their gratitude, saying, "This would NOT be possible without your help and support, let alone the entire Sheriff's Office. Thank you SO much for everything you have done and keep up the amazing work."

CASE SPOTLIGHT

STOLEN MUSCLE-CAR RING: BUSTED!

The Clark County Sheriff's Office Tactical Detective Unit (TDU) recently completed a four-month investigation and arrested five people involved in a multi-state stolen muscle car ring, totaling 23 felony charges.

Detectives recovered the following the case:


- \$700,000 in stolen cars (11 vehicles)
- \$42,000 in cash
- Nine firearms

Detectives authored and secured 13 search warrants as part of their investigation, which began in June 2024. TDU worked alongside the Multnomah County Sheriff's Office, conducting a similar investigation into high-end stolen cars.

CCSO Detectives learned that suspects in the theft ring had a sophisticated method of selecting their vehicles. They would surveil and then burglarize local car dealerships with a stock of high-end cars like Dodge Hellcats and Chevy Corvettes. The suspects would also pay people to scout out privately owned muscle cars, and members of the organized theft ring would steal them and either sell them or part them out for profit. Though the ring affected communities in different states, detectives learned that suspects in Vancouver supported the theft ring in this manner: suspects would provide the operation's ringleader with information on cars, purchase stolen cars he already had, part them out, or swap the vehicle's VIN (vehicle identification number). Some would sell the stolen car parts to other theft ring members.

Through a determined effort, law enforcement recovered multiple high-end cars in Vancouver that were stolen as far south as San Francisco and north as Bellingham, Washington. Detectives believe this particular theft ring started as early as July of 2023.

Detectives recovered a safe holding \$36,000 in cash along with the stolen vehicles. The money was concealed in ammunition boxes and is believed to be connected to the theft ring. The safe's owner is one of the five people charged in the case. The Clark County Sheriff's Office appreciates our partnership with the Multnomah County Sheriff's Office, the Multnomah County District Attorney's Office Auto Theft Task Force, and the Washington County Sheriff's Office.



SCAM

BEWARE OF PHONE SCAMS

We want to remind you that phone scammers are posing as law enforcement officers and targeting Clark County residents! The scammer claims to be from the Clark County Sheriff's Office (or other agencies) and threatens that the victim will be arrested if "unpaid fines" are not paid immediately. They spoof government phone numbers to appear affiliated with law enforcement agencies. They often pose as a sergeant, detective, or deputy and can be convincing. CCSO often calls people but does **not** ask for money and **never** indicates that money can be paid instead of arrest.

Scammers often ask victims to deliver cryptocurrency or gift cards so money can't be tracked. We've taken reports from people scammed out of amounts as high as \$8,000, but the most common amount the scammers ask for seems to be \$2,500. If you receive a suspicious call from someone claiming to be from a law enforcement agency, immediately call the non-emergency dispatch line – 311.

TIPS NEEDED

CATHERINE DAWES

Catherine Dawes, a 27-year-old mother of three, was murdered on January 18th, 1982. She had only recently begun work at a Minit Mart in Southeast Vancouver and was trying to make extra money so her family could pay their bills.

Catherine had just locked the door to close the store for the evening and when a man with a gun shot and killed her. He also attempted to rape her but was interrupted by customers trying to enter the store.

There is one person of interest in this case: a man described as between 6' to 6'2" and slim, with long dark hair and an olive complexion. A witness reported seeing a blue motorcycle helmet on the counter at about 1 a.m., when the front doors were locked. After he left, another witness, a taxi driver, saw the front door open, but no one was in the store, and the helmet was gone.

A unique pair of motorcycle gloves, along with the helmet, were found on the counter. The gloves are described as black and elbow-length, with white stitching around the hand and finger portions. It is possible that the helmet and gloves belonged to the person of interest, or to someone else entirely.

CCSO'S BODY-WORN CAMERA PROGRAM



Greetings,

We are nearing the first anniversary of going live with our Body-Worn Camera (BWC) program. All Deputies, Sergeants, Commanders, Chiefs, and the Sheriff have been trained and issued a BWC. Nearly every marked patrol car in the Sheriff's Office fleet has two in-car cameras, one forward-facing and one prisoner compartment.

The BWC program has proven invaluable in aiding investigations and promoting transparency in the community. By posting videos on the Sheriff's website and other social media platforms, Sheriff Horch is committed to being open about his staff's work.

Work continues in other areas; the Public Disclosure Unit receives approximately 50 monthly requests for BWC and in-car camera footage. Each request generally has multiple videos, but typically at least three, depending on the number of deputies on the scene and the call type. We have increased the number of BWC unit staff by adding one deputy to assist the BWC Sgt.

With the number of newly hired deputies, CCSO has had to purchase more equipment. Another \$250,000.00 (=/-) left over from the original BWC budget has been used to purchase body-worn cameras, in-car cameras, Taser devices, licenses, and other items.

We are grateful for the community support and hope you see the value of the BWC program, too.


