I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). This Challenge is not based upon unsupported allegations or allegations of anonymous third parties. It is noted hearsay evidence is admissible in support of this Challenge (Ref. RCW34.05). Having exercised due diligence to personally verify the evidence presented on information and belief, the following is the factual basis for the Voter Challenge:

- Secretary of State (SOS) Voter Registration Database (VRDB): Wendi Adams, the above-listed voter, is identified as living at residential address 329 S Hubbard Ave, Yacolt, WA. She has not voted in 20 years. Research below supports that she does not reside at the VRDB residential address as currently listed in her voter registration. See attached.
- <u>Citizen Affidavit</u>: An affidavit was obtained from a current resident and relative who confirmed that Wendi Adams does not live at 329 S Hubbard Ave, Yacolt, WA. See attached.
- <u>Certified Mail Receipt</u>: A required attempt was made to contact Wendi Adams at the registered mailing address in Yacolt via a letter and a USPS certified mail receipt. <u>See</u> attached.


