 confirmed that Thomas Beseau does not live at 403 E Alexander St, Yacolt, WA. See
 attached.
- <u>Certified Mail Receipt</u>: A required attempt was made to contact Thomas Beseau at the registered mailing address in Yacolt WA via a letter and a USPS certified mail receipt. <u>See attached</u>.


