Statutory Provisions

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). This Challenge is not based upon unsupported allegations or allegations of anonymous third parties. It is noted hearsay evidence is admissible in support of this Challenge (Ref. RCW34.05). Having exercised due diligence to personally verify the evidence presented on information and belief, the following is the factual basis for the Voter Challenge:

- Secretary of State (SOS) Voter Registration Database (VRDB): Ashley Birdwell, the above-listed voter, is identified as living at residential address 538 E 7th Street, La Center, WA. She has never voted since registering in 2023. Research below supports that she does not reside at the VRDB residential address as currently listed in her voter registration. See attached.
- 2. <u>Citizen Affidavit</u>: An affidavit was obtained from a current resident who confirmed that Ashley Birdwell does not live at 538 E 7th Street, La Center, WA. <u>See attached</u>.
- Certified Mail Receipt: A required attempt was made to contact Ashley Birdwell at the registered mailing address in Vancouver via a letter and a USPS certified mail receipt. See attached.
- 4. <u>Search People Free</u>: A search on website https://www.searchpeoplefree.com/ identified Ashley Birdwell as still living at 538 E 7th Street, La Center, WA. See attached.
- Cyber Background Checks: A search on website https://www.cyberbackground-checks.com/ identified Ashley Birdwell as still living at 538 E 7th Street, La Center, WA. See attached.

- **GIS Property Tax Records**: Ashley Birdwell does not own property in Clark County per GIS data from the Clark County Treasurer's office.
- 7. <u>Voter Registration Verification</u>: Website https://voteref.com/voters/ contains the voter registration databases of at least 30 states. Ashley Birdwell is shown to be registered to vote in Washington. See attached.
- 8. Washington DOC Inmate Search: https://www.doc.wa.gov/information/inmate-search website search shows no current incarceration for anyone named Ashley Birdwell. See attached.
- 9. <u>Clark County Jail Roster</u>: Website https://clark.wa.gov/jail-services/jail-rostersearch shows no current incarceration for anyone named Ashley Birdwell. See attached.


