Statutory Provisions

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) - (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). - <u>Secretary of State (SOS) Voter Registration Database (VRDB)</u>: Christina Brachais, the above-listed voter, is identified as living at residential address 517 E Timber Way, Yacolt, WA. She has not voted in 11 years, since 2013. Research below supports that she does not side at the VRDB residential address as currently listed in her voter registration. See attached.
- 2. <u>Citizen Affidavit</u>: An affidavit was obtained from a current resident who confirmed that Christina Brachais does not live at 517 E Timber Way, Yacolt, WA. <u>See attached</u>.
- <u>Certified Mail Receipt</u>: A required attempt was made to contact Christina Brachais at the registered mailing address in Yacolt via a letter and a USPS certified mail receipt. <u>See attached</u>.
- Search People Free: A search on website <u>https://www.searchpeoplefree.com/</u> identified a Christina Brachais as living at 1115 NE 65th Street, Vancouver, WA. See attached.
- 5. <u>Cyber Background Checks</u>: A search on website <u>https://www.cyberbackground</u> <u>checks.com/</u> identified a Christina Brachais as living at 1115 NE 65th Street, Vancouver, WA. <u>See attached</u>.
- 6. <u>GIS Property Tax Records</u>: Christina Brachais does not own any property in Clark County per GIS data from the Clark County Treasurer's office.

- <u>Voter Registration Verification</u>: Website <u>https://voteref.com/voters/</u> contains the voter registration databases of at least 30 states. Christina Brachais is registered to vote in Washington. <u>See attached</u>.
- 8. <u>Washington DOC Inmate Search</u>: <u>https://www.doc.wa.gov/information/inmate-search</u> website search shows no current incarceration for anyone named Christina Brachais. <u>See attached</u>.
