- Citizen Affidavit: An affidavit was obtained from the current resident who confirmed that Frank Gawthorne does not live at 345 E 7th Street, La Center, WA. See attached.
- 3. <u>Certified Mail Receipt</u>: A required attempt was made to contact Frank Gawthorne at the registered mailing address in La Center via a letter and a USPS certified mail receipt. It was returned as undeliverable. <u>See attached</u>.
- 4. <u>Search People Free</u>: A search on website <a href="https://www.searchpeoplefree.com/">https://www.searchpeoplefree.com/</a> identified Frank Gawthorne as living at 1000 SE 160th, Apt FF261, Vancouver WA. See attached.
- 5. <u>Cyber Background Checks</u>: A search on website <a href="https://www.cyberbackground-checks.com/">https://www.cyberbackground-checks.com/</a> identified Frank Gawthorne as living at 1000 SE 160th, Apt FF261, Vancouver WA. See attached.
- **6. GIS Property Tax Records:** Per GIS data from the Clark County Treasurer's office, an individual with the name Frank Gawthorne owns property at 14601 NE Parkinen

Rd, Brush Prairie, WA. It is unclear if this is the same voter or someone else with the same name.

- 7. <u>Voter Registration Verification</u>: Website <a href="https://voteref.com/voters/">https://voteref.com/voters/</a> contains the voter registration databases of at least 30 states. Frank Gawthorne is shown to be registered to vote in Washington. See attached.


