- 4. Search People Free: A search on website https://www.searchpeoplefree.com/ identified Shantelle Hannu as living at 24782 50th Ave, Cushing, MN. See attached.

- 6. <u>GIS Property Tax Records</u>: Shantelle Hannu does not own property in Clark County per GIS data from the Clark County Treasurer's office.
