WHEREAS, the Board of Directors of Mount Pleasant School District No. 29-93, after careful review and discussion and in accordance with RCW 84.52.053, have determined that an excess levy ballot be put to the voters so as to maintain quality educational programs.

THEREFORE, BE IT RESOLVED, that the registered voter s of the Mount Pleasant School District No. 29-93 be asked to approve a three-year excess levy of \$195,000 in 2026, 2027, and 2028 at the estimated \$2.13 per one thousand dollars (\$1,000) of assessed valuation to be collected in the calendar years 2026, 2027, and 2028 for the election to be held on the 11th day of February, 2025.
