Statutory Provisions

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/ mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). This Challenge is not based upon unsupported allegations or allegations of anonymous third parties. It is noted hearsay evidence is admissible in support of this Challenge (Ref. RCW34.05). Having exercised due diligence to personally verify the evidence presented on information and belief, the following is the factual basis for the Voter Challenge:

1. **Secretary of State (SOS) Voter Registration Database (VRDB)**: Lorraine Schaff, the above-listed voter, is identified as living at residential address 8804 NE 79th Street, Vancouver, WA. She has never voted since registering to vote in 2020. Research below supports that she does not reside at the VRDB residential address as currently listed in her voter registration. **See attached.**
2. **Citizen Affidavit**: An affidavit was obtained from a current resident who confirmed that Lorraine Schaff does not live at 8804 NE 79th Street, Vancouver, WA. **See attached.**
3. **Certified Mail Receipt**: A required attempt was made to contact Lorraine Schaff at the registered mailing address in Vancouver via a letter and a USPS certified mail receipt. It was returned as undeliverable. **See attached.**
4. **Search People Free**: A search on website <https://www.searchpeoplefree.com/> identified a Lorraine Schaaff as living at 616 Martin Way, Vancouver, WA. Note that her last name is spelled differently than what is listed on the VRDB. **See attached.**
5. **Cyber Background Checks**: A search on website <https://www.cyberbackgroundchecks.com/> identified a Lorraine Schaaff as living at 616 Martin Way, Vancouver, WA. Note that her last name is spelled differently than what is listed on the VRDB. **See attached.**

6. **GIS Property Tax Records:** Lorraine Schaff or Lorraine Schaaf does not own any property in Clark County per GIS data from the Clark County Treasurer's office.
7. **Voter Registration Verification:** Website <https://voteref.com/voters/> contains the voter registration databases of at least 30 states. Lorraine Schaff is registered to vote in Washington. See attached.
8. **Washington DOC Inmate Search:** <https://www.doc.wa.gov/information/inmate-search> website search shows no current incarceration for anyone named Lorraine Schaff or Lorraine Schaaf. See attached.
9. **Clark County Jail Roster:** Website <https://clark.wa.gov/jail-services/jail-rostersearch> shows no current incarceration for anyone named Lorraine Schaff or Lorraine Schaaf. See attached.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested that the voter be removed forthwith from the voter roll, or the government show good cause in writing why this particular voter may not be so removed from the roll.
