### **Statutory Provisions**

- Cyber Background Checks: A search on website <a href="https://www.cyberbackground-checks.com/">https://www.cyberbackground-checks.com/</a> identified Simon Strickland as still living at 505 N Hubbard Ave, Yacolt, WA. See attached.

- **GIS Property Tax Records:** Simon Strickland does not own property in Clark County per GIS data from the Clark County Treasurer's office.


