- <u>Certified Mail Receipt</u>: A required attempt was made to contact Camille Trefts at the registered mailing address in Vancouver WA via a letter and a USPS certified mail receipt. <u>See attached</u>.
- 4. <u>Search People Free</u>: A search on website <u>https://www.searchpeoplefree.com/</u> identified Camille Trefts as still living at 2416 NW 113th St, Vancouver, WA. <u>See</u> attached.
