#### Statutory Provisions

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailing letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). This Challenge is not based upon unsupported allegations or allegations of anonymous third parties. It is noted hearsay evidence is admissible in support of this Challenge (Ref. RCW34.05). Having exercised due diligence to personally verify the evidence presented on information and belief, the following is the factual basis for the Voter Challenge:

- <u>Secretary of State (SOS) Voter Registration Database (VRDB)</u>: Cody Wilcox, the above-listed voter, is identified as living at residential address 10716 NW 26th Ave, Vancouver, WA. He has never voted since registering in 2015. Research below also supports that he does not reside at the VRDB residential address as currently listed in his voter registration. See attached.
- 2. <u>Citizen Affidavit</u>: An affidavit was obtained from the current resident who confirmed that Cody Wilcox does not live at 10716 NW 26th Ave, Vancouver, WA. <u>See attached</u>.
- <u>Certified Mail Receipt</u>: A required attempt was made to contact Cody Wilcox at the registered mailing address in Vancouver WA via a letter and a USPS certified mail receipt. <u>See attached</u>.
- <u>Search People Free</u>: A search on website <u>https://www.searchpeoplefree.com/</u> identified Cody Wilcox as still living at 10716 NW 26th Ave, Vancouver, WA. <u>See</u> attached.
- <u>Cyber Background Checks</u>: A search on website <u>https://www.cyberbackground</u> <u>checks.com/</u> identified Cody Wilcox as still living at 10716 NW 26th Ave, Vancouver, WA. <u>See attached</u>.

- 6. <u>GIS Property Tax Records</u>: Cody Wilcox does not own property in Clark County per GIS data from the Clark County Treasurer's office.
- 7. <u>Voter Registration Verification</u>: Website <u>https://voteref.com/voters/</u> contains the voter registration databases of at least 30 states. Cody Wilcox is shown to be registered to vote in Washington. <u>See attached</u>.
- 8. <u>Washington DOC Inmate Search</u>: <u>https://www.doc.wa.gov/information/inmate-search</u> website search shows no current incarceration for anyone named Cody Wilcox. See attached.
- 9. <u>**Clark County Jail Roster**</u>: Website <u>https://clark.wa.gov/jail-services/jail-rostersearch</u> shows no current incarceration for anyone named Cody Wilcox. <u>See attached</u>.
