#### **Old Business**

## Approval of minutes for February 12, 2025.

- ACTION: Moved by Councilor Yung to APPROVE February 12, 2025, meeting minutes. Councilor Fuentes seconded the motion. All aye/motion passed.
- Bridge Shelter
  - Jordan Boege, Sr. Policy Analyst for Clark County started the conversation regarding the City of Vancouver Bridge Shelter request.
  - The city has requested about \$4.8M to fund the Bridge Shelter.
  - Jordan stated that there has been the use of MHST funds before in the past for permanent or the construction of permanent supportive housing projects.
  - The question still remains: Is Shelter...Housing?
  - o Jordan provided a current list of requests for MHST funding for the next round in August.
    - DISCUSSION; Q & A
      - There are several questions the Council has raised and are requesting additional information.
      - Jamie Spinelli, City of Vancouver explained what the Bridge Shelter is for and how it will assist the County with the homeless population.
- ACTION: Moved by Councilor Little to APPROVE \$2.1M from the MHST which is inclusive of \$450,000 for the ongoing operations for 3 years and \$2.75M from the Opioid Settlement Fund as well as the remainder of the MHST will be limited to internal requests, with an additional request of four years of service for the County. Councilor Yung seconded the motion. Councilor Belkot Abstained, Councilors Yung, Fuentes, Little, and Chair Marshall aye/motion passed.
